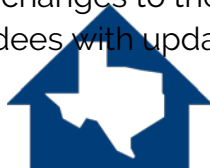
Meeting began at 10:00 AM

I. Welcome and Introductions

- a. Sophia welcomed attendees to the annual in-person joint CoC General and CoC Board meeting.
- b. Introductions
 - i. THN Staff Members introduced themselves
 - ii. Mary acknowledged members of the CoC and THN Boards present.
- c. Sophia announced that this meeting is considered the first meeting for the 2017-18 year.

II. Annual Review

- a. Governance Charter and CoC Policies and Procedures
 - i. Mary reviewed changes to the Governance Charter, and provided attendees with updates regarding the CoC Policies and Procedures.

- ii. Changes to the Governance Charter include: language revisions, Local Homeless Coalition (LHC) map updates, updated MOU between the CoC/HMIS Lead Agency and the CoC Board, and a revised Code of Conduct and recusal process for CoC Board members
- iii. Changes to the CoC Policies and Procedures Include: addition of the CoC and CE Written standards, and adoption of various policies approved by the CoC Board and presented to the general membership throughout the year (Rapid Re-Housing Prioritization Standards, Policy Against the Criminalization of Homelessness, Permanent Supportive Housing Prioritization Standards, policies related to the CoC Program Competition, revised CoC Board responsibilities, and revised LHC requirements).

III. 2016-17 Year-in-Review

a. FY 2016 CoC Program

- i. 26 projects applied in the FY 2016 competition; 21 projects were awarded, including 4 new projects (including new projects in the West Texas area, which has historically been underrepresented). Receiving 4 new projects is an accomplishment not many CoCs can claim. It is a direct result of the efforts the TX BoS CoC put in over the past year (reallocations, Housing First, and systems change work).
- ii. TX BoS CoC members had increased opportunities for training in FY 2016: PSH and RRH Project Design Clinics, OrgCode Learning Clinics and Webinars, and TA offered to help LHCs implement Coordinated Entry. In addition THN hired an additional staff member dedicated to providing more TA to participants, Jim Ward- TA and Performance Coordinator.
- iii. Due to the hard work put in by TX BoS CoC HMIS users, THN was able to submit System Performance Measures on time. The TX BoS CoC also saw its geographic coverage for the Housing Inventory Count (HIC) and Point-in-Time Count (PIT) increase in January 2017.
 - 1. HMIS Users can expect to have access to Resource Track soon. Resource Track will be how users can sign up for training and is available within an HMIS user's ClientTrack account.

- iv. Hurricane Harvey had a devastating impact on 39 counties on Texas' coast, affecting 2,319,773 people in the TX BoS CoC. As the lead agency for the TX BoS CoC, THN will receive disaster recovery Technical Assistance (TA) for the next 3-7 years to aid TX BoS CoC communities in recovery.
- v. Various Community Accomplishments were highlighted both by THN staff and by the CoC General Membership: Cherokee County started a new Local Homeless Coalition, Denton permanent hired their VISTA member after completion of her service term to work on Coordinated Entry, Temple submitted a collaborative application for ESG funding rather than competing against one another, Abilene and Lubbock are using a 100-day challenge to pilot implementation of Coordinated Entry, etc.

IV. 2017-18 Plans

- a. CoC Work Plan/Strategic Plan
 - i. THN continues to work with the CoC Board and TX BoS CoC TA providers to create a work plan. Sophia provided a sample of what the work plan will look like once completed, and explained the SMART goals model.

 - i. At this time, the FY2017 CoC Program Competition is in a holding pattern, THN will reach out to applicants when a timeline has been made official.

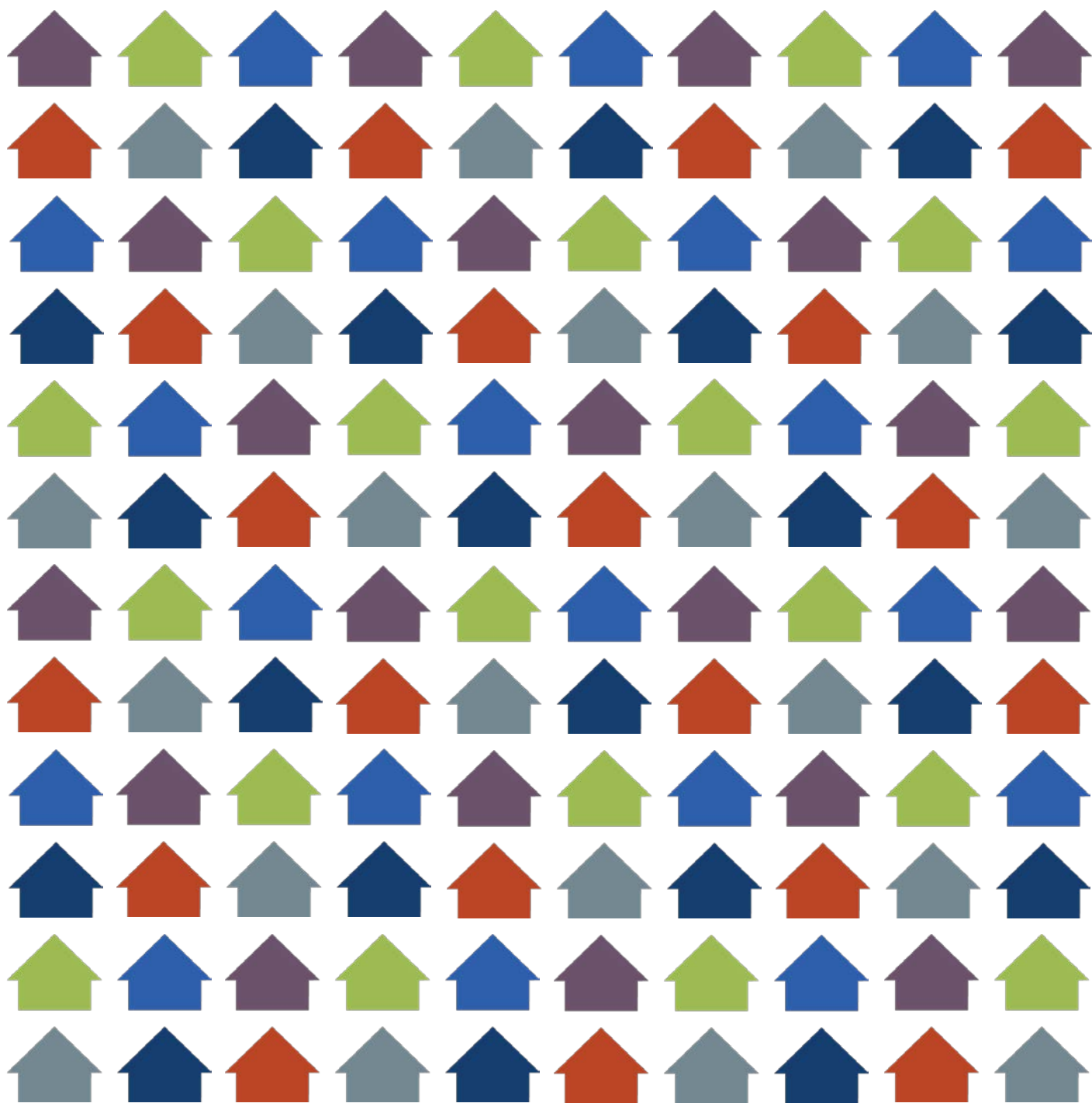

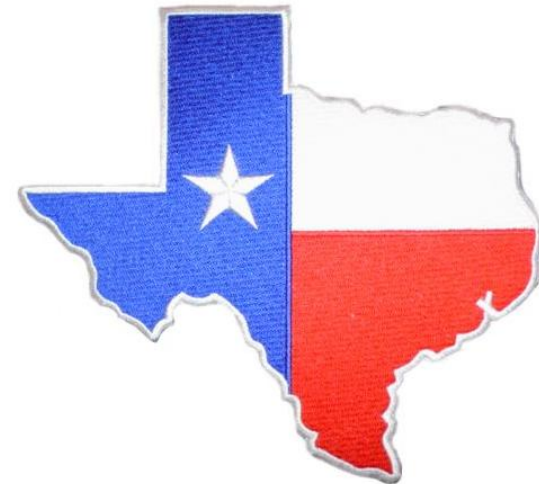

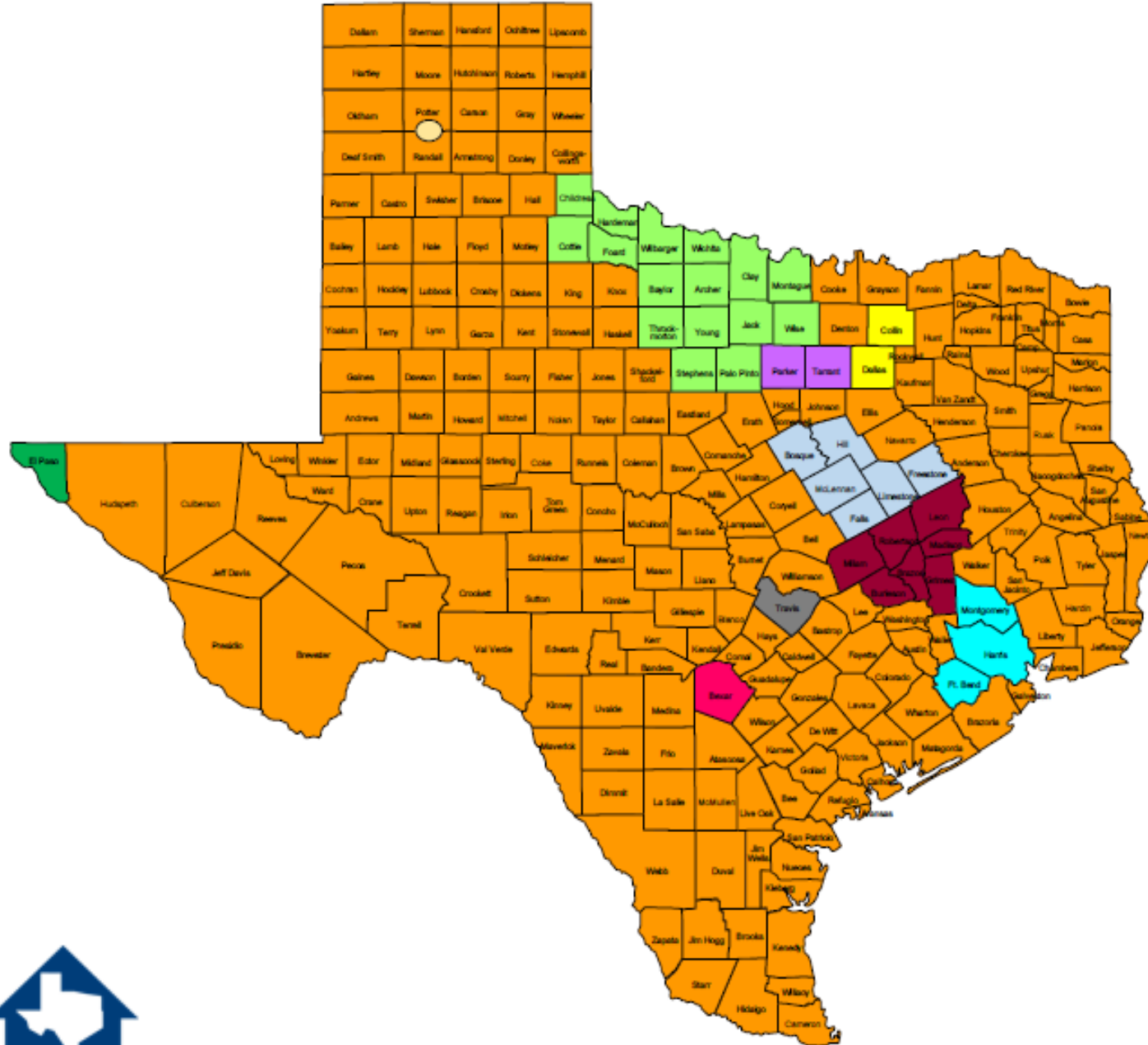
- Incorporated in 1991 to help the Texas Interagency Council for the Homeless (TICH) carry out its legislatively mandated activities











THN and the TX BoS CoC

Annual Review Requirement

- CoC Interim Rule—24 CFR 578

578.7 (a)(5) In consultation with the collaborative applicant and the HMIS Lead, develop, follow, and update annually a governance charter, which will include all procedures and policies needed to comply with subpart B of this part and with HMIS requirements as prescribed by HUD; and a code of conduct and recusal process for the board, its chair(s), and any person acting on behalf of the board;



Governance Charter Language

Approval, Annual Review, and Update

- In consultation with the Collaborative Applicant/CoC Lead Agency and the HMIS Lead Agency, this Charter shall be adopted at a regular TX BoS CoC General Meeting by a simple majority (at least 51%) affirmative vote of the members present and determined eligible to vote. (Done 3/25/2015, 9/21/2016)
- The Charter may be thereafter amended at a regular TX BoS CoC General Meeting by a simple majority (at least 51%) affirmative vote of the members present and determined eligible to vote. The Governance Charter may be fully revised to include agreed-upon changes, or an Amended Article may be added for insertion into the existing document.
- TX BoS CoC Board and membership will annually review and update, as necessary, the TX BoS CoC Charter, in consultation with the Collaborative Applicant/CoC Lead Agency and the HMIS Lead Agency.

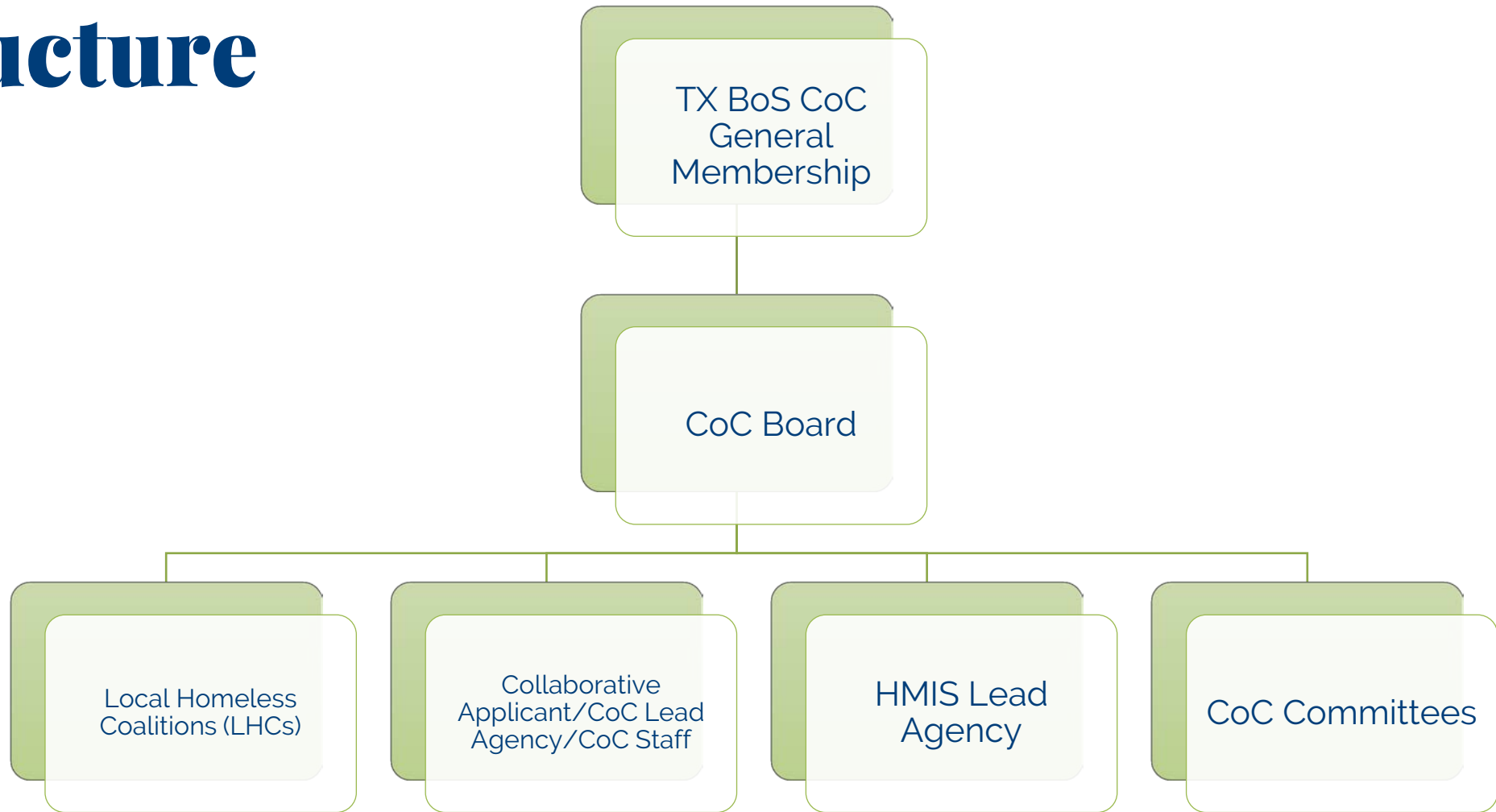

CoC P&Ps Adopted 9/10/16–9/13/17 (cont.)

- **Coordinated Entry (CE) Written Standards**
- Outlines the framework for Coordinated Entry in the TX BoS CoC
- Every community will have a system in place with the capacity to:
 - Quickly identify and engage people at risk of and experiencing homelessness
 - Intervene to prevent the loss of housing and divert people from entering the housing crisis response system
 - When homelessness does occur, provide immediate access to shelter and crisis services, without barriers to entry, while permanent stable housing and appropriate supports are being secured, and quickly connect people to housing assistance and services – tailored to their unique needs and strengths – to help them achieve and maintain stable housing.

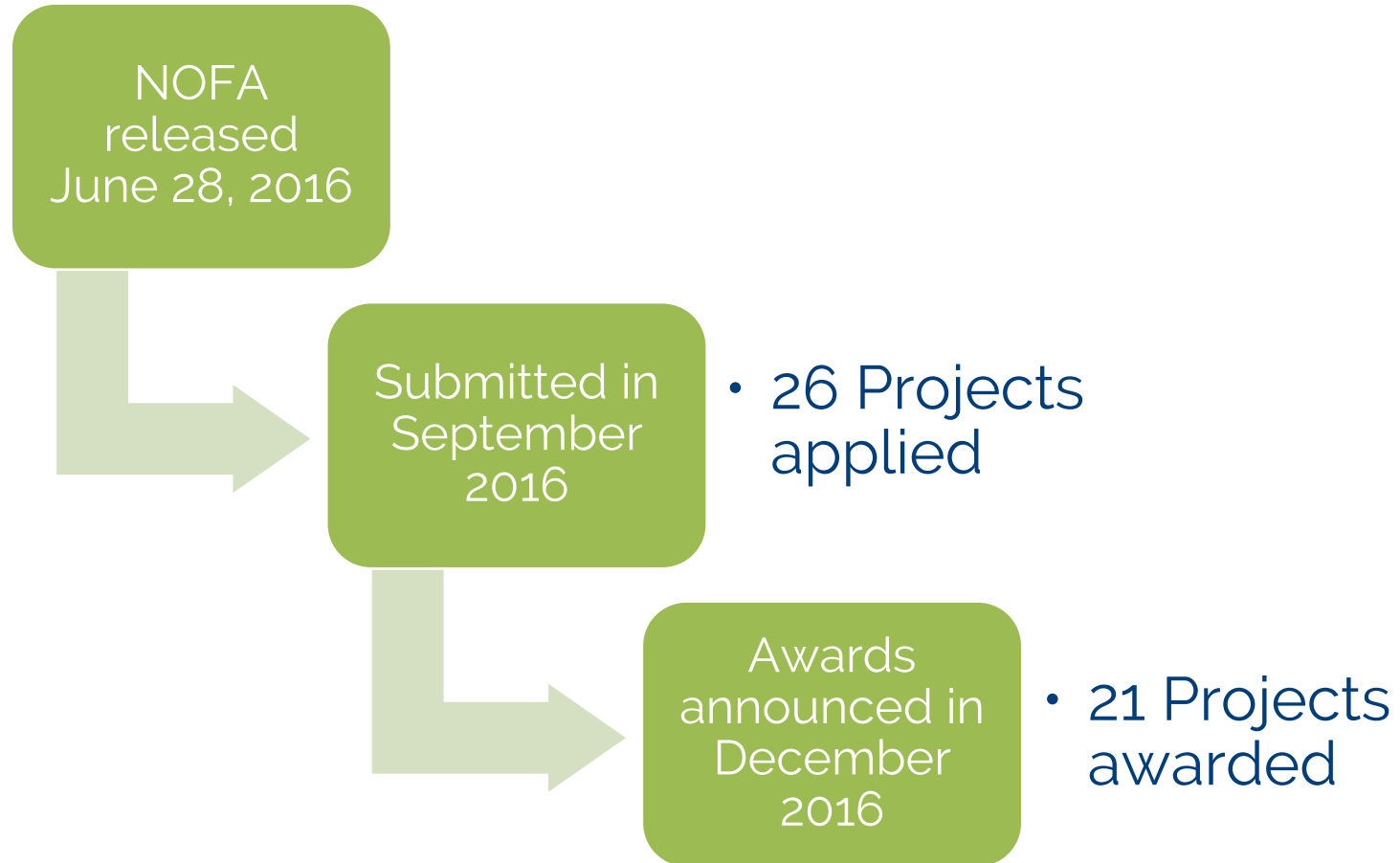

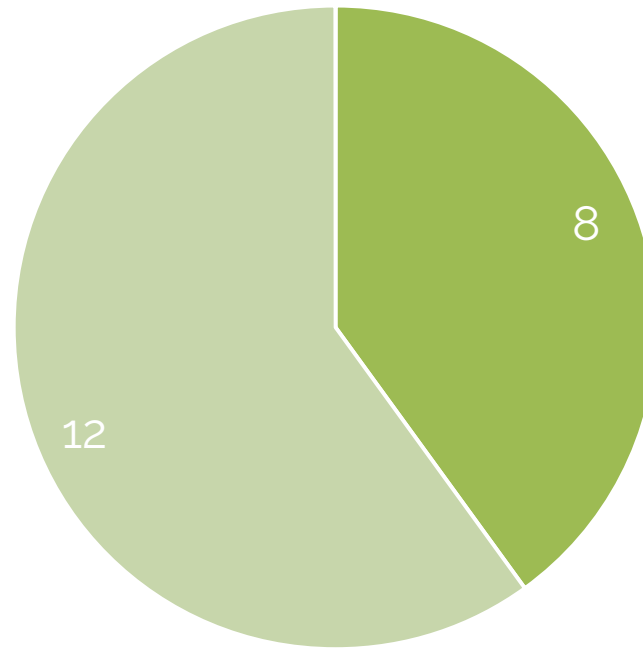

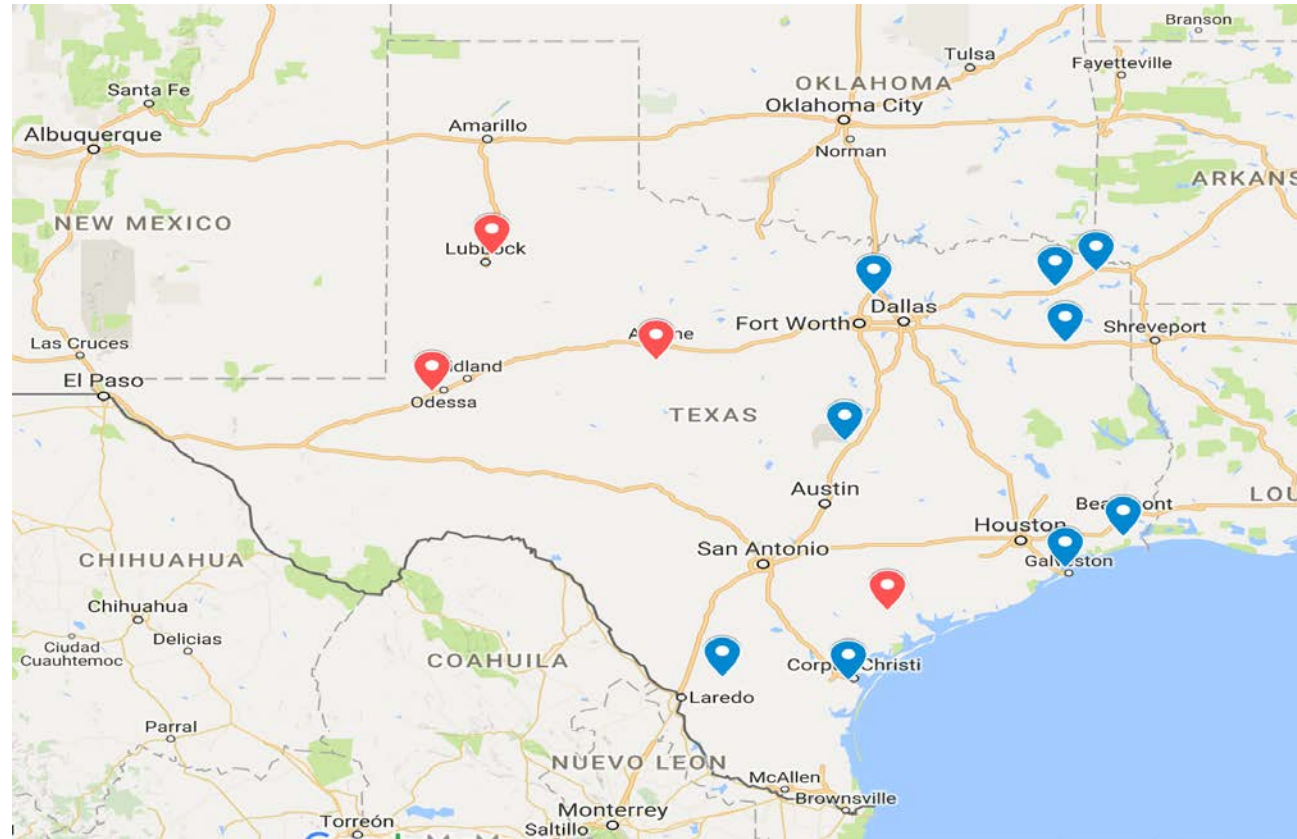

CoC Board Elections

- The CoC is required to establish a Board that acts on behalf of the CoC.
- The Board must be representative of the relevant organizations within the CoC's geographic area and of projects serving homeless subpopulations, including at least one person with lived experience (who is currently or formerly homeless).
- Board Members will have responsibilities and duties described in the Board Member Requirements Policy and Procedures, including complying with a Code of Conduct and a Conflict of Interest Statement.

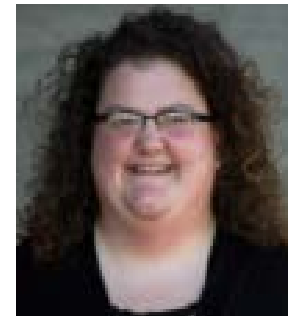
