Minutes:

Meeting began at 2:05 PM.

I. Welcome, Introductions, and Map.

a. Kameron welcomed attendees to the meeting and had staff in the room introduce themselves. There continues to be wide representation across the CoC's geography. She encouraged attendees to keep coming to meetings and

to pass on the meeting information with their Local Homeless Coalitions (LHCs) and community members.

b. Feel free to ask questions/raise your hand at any time in the webinar. Your participation is important!

II. CoC Current Priority Projects

- a. Coordinated Entry (CE) Update
 - i. Written Standards- The Coordinated Entry Written Standards provide the required standards that local implementations of Coordinated Entry must meet. TX BoS CoC staff have set an internal deadline for finalizing the standards for next week so that the Board has time to review them and vote on them during the CoC Board meeting on May 24th.
 - ii. Systems Change Toolkit- THN released the Systems Change Toolkit in March. This toolkit provides the framework, resources, and tools needed to begin developing local Coordinated Entry processes. It is available now via Google Docs.  - iii. Coordinated Entry Facilitator Webinars- THN's Systems Change Coordinator, Sophia Checa, is hosting webinars to support communities implementing Coordinated Entry every Thursday from 2-3pm until June 8. The webinars will review toolkit materials and provide facilitators of the local implementation process a chance to ask questions and brainstorm solutions. Register for the webinar series here:

b. HMIS -

- i. The HMIS team is hard at work on the System Performance Measures in preparation for the upcoming CoC Program funding competition.
- ii. New Data Quality Reports- Available now! HMIS-using projects should have received a new data quality report from the HMIS team. Be sure to acknowledge that you received the e-mail when you receive it by sending a quick reply to the HMIS team.
- iii. Annual Performance Reports (APRs) ClientTrack, the TX BoS CoC's HMIS vendor, made the new format available at the end of April. The new format will be used to help CoC Program recipients upload APR data to Sage to complete HUD reporting requirements.
- iv. New HMIS Data Standards will be released soon. However, the updated Data Dictionary is available now on HUD Exchange. The new Data Standards contain relatively few changes and we anticipate they will be much easier than prior years' Data Standards updates. CoCs have until October to fully implement the new standards, so the HMIS

team will be working with all HMIS-using projects on implementation in the near future.

- v. The HMIS team now holds monthly webinars. The next HMIS Webinar will be held on 5/25. If you're using HMIS and are not receiving invitations to attend the webinars, please e-mail the HMIS team at hmis@thn.org. For those users unable to attend, the webinars will be posted to THN's YouTube channel. If you're using HMIS, please attend the webinars to keep up with reporting requirements and best practices. The HMIS team is also considering doing an "office hours" webinar monthly. Stay tuned for the announcement!
- c. CoC Written Standards- TX BoS CoC staff are working to incorporate revisions and comments to the CoC Written Standards. The CoC Board will vote on whether to adopt them during the CoC Board meeting on May 24th. If adopted, the CoC Board will also decide on an implementation date at that time.
- d. System Performance Measures (SPMs)-
 - Due to multiple issues with the upload process, HUD allowed all CoCs to re-submit their System Performance Measures. The TX BoS CoC chose to re-submit the 2015 System Performance Measures. TX BoS CoC measures did not change significantly between the original and revised uploads.
 - ii. There will be webinar in June dedicated to reviewing the last two years' of System Performance Measures and how the CoC will continue to work on them moving forward. The HMIS team is still working on making community-level System Performance Measure reports available.
 - iii. Differences for this year's System Performance Measure upload- HUD incorporated a new Data Quality report. HUD didn't advise CoCs before implementing the new Data Quality report into the System Performance Measure report, so projects will likely be contacted by the HMIS team about potential needed corrections over the next few weeks. Please respond in a timely manner so they don't have to take time to track you down. This data is important for the CoC to be able to track progress toward ending homelessness, but it is also important for CoC Program competition purposes. The data affects the CoC Application score, which also contributes to project applications' scores. The CoC is in a rush this year to complete the System Performance Measure report because the TX BoS CoC's HMIS vendor didn't get the needed reports into the system as quickly as was hoped. Thank you for your help and timely response!
- e. Point-In-Time (PIT) Count Review
 - i. The TX BoS CoC submitted the Housing Inventory Count (HIC) and Point-In-Time (PIT) Count data to HUD last Friday.

- ii. Kristin Zakoor, Data Coordinator for the TX BoS CoC, reviewed the highlights of PIT Count data. Community reports will be up on the THN website by the end of this week. Those Local Homeless Coalitions (LHCs) that participated in the 2017 PIT Count should have already received these reports, however. The TX BoS CoC-wide narrative report is still in development. The 2017 PIT Count showed an overall increase in people experiencing homelessness. Kristin stated that this was likely due to improvements in outreach, volunteer numbers, and additional community participation.
- iii. PIT De-Brief Webinar, 2:00 PM, May 30th- Kristin will hold a PIT de-brief webinar. An invitation with a registration link will be sent out soon to PIT Count leads and LHC Chairs. This webinar will focus on collecting community feedback about what did and did not work in this year's count.
- iv. Kameron acknowledged and thanked those communities that participated in the 2017 PIT count. We know this count requires a lot of work, so thank you! We look forward to sharing the more detailed reports with you all in future meetings.

III. Announcements

- a. HUD CoC Program application and competition
 - i. Registration and Grant Inventory Worksheet (GIW) completed- Texas Homeless Network (THN), the TX BoS CoC Collaborative Applicant, completed the CoC Registration process on behalf of all projects in the TX BoS CoC geographic area. THN also submitted the GIW to HUD with no changes. The finalized GIW will be released back to the CoC no earlier than June 9.
 - ii. HUD's Notice of Funding Availability (NOFA) likely to be released soon- While no one knows exactly when it will be released, we do know we will have more time for the competition than we did last year (120 days vs 90 days). The current estimation is late May/early June. In order to start preparing for the CoC Program competition, CoC Program-funded projects planning to apply for renewal funding should start looking at LOCCS data and begin filling in the spreadsheet that was distributed last year. It is also a good idea to review your project's data with an eye for performance and data quality in HMIS. It is strongly recommended that potential new and renewal projects review the 2016 RFP and timeline on THN's website, thn.org, to get a better idea of the tasks ahead. Don't wait until the NOFA is released to get started on preparing for competition. There are several projects in the TX BoS CoC that will not have project data to use for scoring their applications, as their contracts haven't started yet, and their projects haven't started operating yet. Thus they will be "held harmless" and

- ranked in the bottom of Tier 1. Due to the number of projects this designation applies to this year, Tier 1 slots for projects that do have project data will be more limited, making acquiring those Tier 1 slots more competitive. The higher a project is ranked by the CoC, the more likely it will receive CoC Program funding, so ranking is critical.
- iii. TX BoS CoC's Request for Proposals (RFP) released after the NOFA-Just as the NOFA from HUD kicks off the CoC national competition, the Request for Proposals (RFP) kicks of the CoC ("local") competition. The RFP provides CoC-level guidance on submitting an application for a new or renewal project. Once the RFP is released, THN will hold a webinar to review it with applicants. All applicants are strongly encouraged to participate in the webinar. The webinar date will be released after HUD releases the NOFA.
- b. OrgCode trainings on emergency shelter and housing stabilization- Space is quickly running out for these trainings. There are 4 seats open for the Corpus Christi training and 8 seats open in Galveston. Once those seats are filled, no one else will be able to register. Because there is such high demand and limited space, please let us know if you are unable to attend so we can open the space up for others. To help fill in seats, a waitlist will be added.
 - i. June 12-13 in Corpus Christi
 - ii. June 15-16 in Galveston
- c. PSH Clinic feedback- Last week THN and HUD TA providers, CSH, held a 2-day training with CoC Program-funded Permanent Supportive Housing (PSH) projects. Attendees dug into Housing First, CoC Program regulations, and HUD administrative requirements. It was a great opportunity for grantees to network with their peers. Materials will be sent out to attendees by the end of the week along with lots of additional resources. The materials will be shared through Google Drive or Drop Box due to their large volume.
- d. FY 2017 Funding- The National Low Income Housing Coalition (NLIHC) sent an e-mail regarding federal funding announcements that pertain to affordable housing. Congress passed the FY2017 Federal spending bill on May 4th. The passed budget does not include the \$18 billion cut for non-defense projects that the administration had proposed. Most HUD programs are receiving atlevel or more funding than the prior year's budget. The only HUD programs to see cuts were the public housing operation fund and section 811 for people with disabilities. Additionally, the budget increases homeless assistance from \$2.25 billion to \$2.383 billion and extends authorization for the United States Interagency Council on Homelessness (USICH) for one more year. FY 2018 budget work may begin soon, so stay alert for information about continuing to fund homeless assistance and housing programs.
- e. State Emergency Solutions Grant (ESG) Program- With the release of the FY2017 federal budget, we hope that the funding allocation to TDHCA will come very soon. TDHCA is waiting to set the ESG application due date until

they receive their allocation from HUD. So far, the TX BoS CoC has 25 projects applying. Mary stated that even if applicants don't receive ESG funding through TDHCA, applicants can be confident that the collaborations and project designs used for the ESG Program competition could be used to seek funding from other sources.

- f. VISTA Announcement-Jason Phillips, VISTA Program Coordinator, will be leaving THN for a program manager position in Austin. His last day is May 26th. If he is waiting for any documents from a current/potential VISTA site (MOUs, forms, etc.), please turn them into Jason ASAP! If your organization is interested in a VISTA, get the process started with Jason before he leaves! There is always a transition period with new staff, so it is best to start work on applying for a VISTA project earlier rather than later.
- g. HUD Financial Training- HUD released an online training module that provides guidance on managing HUD CPD Grants (HOME, HOPWA, CDBG, ESG, and the CoC Program). All CPD grant recipients are highly recommended to take advantage of this free training. Find the training by clicking here.
- h. SNAPS Data Strategy (SNAPS In-Focus) The Office of Special Needs Assistance Programs (SNAPS) released an article about their long-term data strategy for homeless assistance programs. If attendees wonder why there is a shift toward data quality and using performance data to make funding decisions, this is an essential read. Check out the article by clicking here.
- Sage training and resources available- On April 1, HUD transitioned from using e-snaps to Sage HMIS for completion of reporting requirements for CoC Program-funded projects. To help with this transition, HUD has provided guidance on using the new submission portal. You may find those resources on the <u>HUD Exchange</u>.
- j. National Alliance to End Homelessness (NAEH) Conference, July 17-19- NAEH is a leading voice on the issue of ending homelessness. Sign up for their conference! Do so quickly, as the registration and hotel rooms fill up very quickly. Register here.
- k. With the CoC Program competition upcoming, the CoC General meeting schedule will likely change. We will keep you informed of any schedule changes via the THN listserv.

FY 2017 Funding



May 1, 2017

Ending months of uncertainty, Congress passed its final Fiscal Year (FY) 2017 spending bill on Thursday, May 4. The bill passed with bipartisan support in both chambers by a vote of 309-118 in the House and 79-18 in the Senate. At more than \$1.07 trillion, the final budget agreement upholds the bipartisan deal made in late 2015 to lift the spending caps required by Budget Control Act for defense and non-defense programs. The deal does not include any of the \$18 billion in cuts requested by the Trump administration for non-defense programs, which include affordable housing and community development.

Housing and Urban Development

The FY17 spending bill funds most HUD programs at or above FY16 levels, but below the high-water marks provided in the draft versions. This is true for Tenant-Based Rental Assistance, Family Self-Sufficiency, Native American Block Grants, Native Hawaiian Block Grants, Community Development Block Grants, HOME Investment Partnerships programs, Self-Help Homeownership Opportunity Program (SHOP), Homeless Assistance Grants, Project-Based Rental Assistance, Section 202 Housing for the Elderly, Housing Counseling, Policy Development and Research, and Fair Housing and Equal Opportunity.

For some programs, the FY17 bill provides more funding than the levels proposed under the House and Senate draft bills. These include the Public Housing Capital Fund, Choice Neighborhoods Grants, Housing for Persons with AIDS, and Healthy Homes & Lead Hazard Control.

The only programs to see funding cuts compared to FY16 were the Public Housing Operating Fund (\$4.4 billion in FY17 compared to \$4.5 billion in FY16) and Section 811 Housing for People with Disabilities (\$146 million in FY17 compared to \$151 million in FY16).

Homelessness:

The bill increases funding for homeless assistance programs to \$2.383 billion from \$2.25 billion in FY16. The bill targets \$43 million to address youth homelessness and waives the requirement that youth 24 years of age and under provide third-party documentation to receive housing and supportive services within the Continuums of Care. The bill extends the authorization for the U.S. Interagency Council on Homelessness (USICH), which is set to expire this year, by one additional year.
