Meeting began at 2:05 PM

I. Welcome, Introductions, and Map

- a. Kameron welcomed attendees to the meeting. Kameron has just returned to work from maternity leave.
- b. Kameron reminded attendees that they should not share their registration links, as duplicated sign-ins will not allow all attending parties to get attendance credit. - c. Kameron presented the map of the meeting attendees.

II. CoC Current Priority Projects

- a. Coordinated Entry (CE) implementation required by January 23rd!
 - i. Tiffany has made a checklist of documents and tasks you must complete before getting access to the assessor training.
 - 1. 8 communities have completed the checklist (or are very close to completing it!)
 - 9 communities left that we have not received most documentation from: Beaumont, Corpus Christi, Galveston, Hidalgo County, Laredo, Longview, Mt. Pleasant, Odessa, and



Victoria. THN staff will be reaching out to these communities to check in on the implementation process.

- ii. There are consequences from HUD for not fully implementing CE. Your federal funding and the wellness of the CoC depends on communities implementing CE.
- iii. You don't have to wait for your P&P to be approved to continue working on other checklist tasks and documents!
- iv. Starting February, THN will work with the Coordinated Entry Planning Entities (CEPEs) to evaluate the health of local CE processes.
- b. Point-In-Time (PIT) Count and Housing Inventory Count (HIC)
 - i. The PIT count will be held on January 25. If you want to participate in your community's PIT Count but aren't sure how to get involved, please reach out to Kristin Zakoor at kristin@thn.org.
 - ii. PIT Leads: Please remember to get your volunteer sheets signed and volunteer hours tracked. Please also send your PIT time range to Kristin Zakoor at kristin@thn.org so that we can have app IT help available for you during all PIT times.
 - iii. The Housing Inventory Count survey will be sent out to communities soon!
 - iv. THN is considering sending staff to communities during the PIT count. Please let Kristin Zakoor know if you are interested in having a staff member onsite!
 - v. A big thank you to our PIT leads and PIT volunteers for taking on this enormous task! We appreciate you!
- c. HMIS
 - i. Annual Homeless Assessment Report (AHAR) For the second year in a row, the TX BoS CoC has been able to submit all "shells" (i.e. data sets)! Jesus congratulated all HMIS users on their hard work.
 - 1. 2018 will be the first year that RRH will be included in the AHAR
 - Release of Information (ROI) training s will be held January 9th and 11th
 It is a mandatory training, so don't miss it!
 - The ROI is one of the most important documents governing HMIS. It protects client data and confidentiality, thus it is imperative that all HMIS users be able to use and explain it to clients well.
- d. Hurricane Harvey recovery
 - i. HUD allocated \$57.8 mil of CDBG for Texas Harvey Recovery effort. Earlier this month, THN's President/CEO Eric Samuels worked with the Houston CoC to recommend how funds should be allocated by the General Land Office (GLO). THN's recommendation was to provide homelessness prevention and long term rental vouchers, landlord risk mitigation pools, building repair, construction, and supportive services,

among other recommendations. We have not yet heard a response from the GLO, but expect we may hear something within the next week or so, though we still do not know when funds will be released. It is likely TDHCA will be administering these funds, in partnership with CoC Lead Agencies.

 - 3 Communities applied to participate in the Built for Zero Learning Collaborative. They can expect to hear back from us no later than 1/12/18.
