#### Minutes:

Meeting began at 2:01 PM

#### I. Welcome, Introductions, and Map

a. Mary introduced staff members on the line, and welcomed attendees to the meeting.

#### II. Using Adobe Connect meeting software

a. Kraig provided a brief overview of using Adobe Connect, and advised attendees to shut off any programs that could be using bandwidth for the best Adobe Connect experience.

#### III. The CoC and Me

- a. Caitlin introduced this new segment of the meeting. The purpose of The CoC and Me is to encourage member participation by helping members understand how they are connected to the CoC, what their role is, and why they are important.
- b. The focus of this meeting's CoC and Me is "How I Fit In to the TX BoS CoC". The slides are attached to the meeting minutes.
- c. Caitlin challenged attendees to help someone sign up for the CoC mailing list in their communities that wanted to be more involved with the CoC.

#### IV. CoC Current Priority Project



- a. Point-In-Time (PIT) Count January 25, 2018.
  - i. Point-in-time count preparations are in full swing! We have recently posted unsheltered count training materials and a Counting Us app "how to" on our website. Please make sure to check out the materials to help prepare for your volunteer trainings. We will also be recording and posting a sheltered count training video next week so please stay tuned. If you have any questions or concerns please reach out to kristin@thn.org.
  - ii. For those of you who received an email to take the Housing Inventory Count survey, please make sure to complete it by close of business on 12/18/17. The survey should take you around 2 minutes to complete. If you are having issues accessing the survey please email kristin@thn.org
- b. Coordinated Entry (CE)
  - Sept. 1 was the deadline to turn in finalized CE Policies & Procedures Tiffany worked with communities up until Nov. 30 to finalize their Policies & Procedures. However, at this time, only Abilene and Texarkana have CE Policies & Procedures Approved.
  - ii. Communities will not have access to CE training until their Policies & Procedures are completed and a training list is submitted to THN.
    - 1. The training list has 2 parts. 1) people who need HMIS access to do CE, 2) staff from agencies participating in CE that don't need HMIS access
    - 2. January 12 is the cut-off date for having finalized and approved documentation turned in.
  - iii. HMIS live site access to the CE Workflow will be granted on the 23<sup>rd</sup>, but only after all training requirements are completed. If you need to know what those requirements are, look at the implementation checklist in the CE section of the THN website, or email Tiffany Hart at tiffany@thn.org.
- c. HMIS
  - i. The Annual Homeless Assessment Report (AHAR) was submitted successfully on December 1<sup>st</sup>. The HMIS team is confident that all shells will be accepted. This will make the 2<sup>nd</sup> year in a row all shells have been completed and submitted.
  - The HMIS Release of Information (ROI) training is open and mandatory for all HMIS users, as it is universally applicable. It changes the permissions on data access for clients and how we share information. To fully protect client's rights, it is important to make this a priority.
    - 1. Osnium users may be affected by the changes too. Please stand by for more information.
- d. Built for Zero Learning Collaborative

- i. Caitlin introduced an opportunity for communities to receive intense, hands-on Technical Assistance from Community Solutions, leaders of the 100,000 Homes Campaign and Zero: 2016.
- ii. The goal of the Built for Zero Collaborative is to help communities end Veteran and Chronic Homelessness through quality By-Name Lists development, strong Coordinated Entry processes, and leadership.
- iii. While Texas Homeless Network is covering the cost of the Technical Assistance, applicants are expected to pay for their own travel, lodging, and other accommodations.
- iv. To become a part of the Built for Zero Learning Collaborative, submit an application to the TX BoS CoC by 01/09/2018. Selected communities will be notified by 1/12/18. Ability to participate in Built for Zero is dependent on if the TX BoS CoC is accepted by Community Solutions. Communities need not receive federal funding to apply.
- v. If you have questions about participating, please contact Caitlin Bayer at <u>caitlin@thn.org</u>.
- e. Hurricane Harvey recovery
  - i. Eric Samuels and Sophia Checa have been participating in calls with other CoC s across the state to discuss recovery efforts.
  - ii. CDBG-DR is a special type of funding managed by the General Land Office to help communities recovering from Harvey. The planning group of Texas CoCs has made concrete recommendations about how to allocate funding to best serve people experiencing homelessness.
- f. HUD CoC Program competition
  - i. The TX BoS CoC's Consolidated Application was submitted successfully on 11/15/17. To view the priority ranking and the CoC application, visit the Continuum of Care Program page on the THN website. Caitlin demonstrated how to access the Priority Ranking.
  - ii. The TX BoS CoC submitted project applications for 19 renewal and 4 new housing projects.

#### V. Announcements

- a. Rural Supportive Housing Initiative
  - i. Technical Assistance providers CSH and Collaborative Solutions are seeking communities to host workshops on rural solutions for Coordinated Entry, landlord outreach, and housing-based case management
  - ii. Caitlin used a poll to assess member interest in such a workshop, and member preferences on workshop format.
- b. CoC Board election results



- i. This past election cycle, 9 seats were up for election: all oddnumbered seats plus seat 2. Mary introduced the new board members.
- ii. Attendees welcomed new board members. Mary thanked everyone who voted and ran for office.
- c. Emergency Solutions Grant (ESG) Program
  - i. State ESG awards- TDHCA made final funding decisions at the end of Novemebr/beginning of December. ESG contract years are scheduled to start November 1. 9 projects were funded in the TX BoS CoC.
  - ii. There will not be an ESG program competition in 2018. Your next opportunity to apply for State ESG is Jan 2019.
  - iii. CAPER consultations- Consolidated Planning jurisdictions are required to consult with the CoC on certain things. We are also including the LHC in the consultation. If you are in need of a CoC consultation for your Consolidate Planning jurisdiction, reach out to Mary Rychlik at <u>mary@thn.org</u>.
- d. SSVF Letters of Support
  - i. The SSVF FY 2019 NOFA was released in November and is due in January. SSVF grantees are being required to request a letter of support from their CoCs. The deadline to apply for a SSVF Support Letter from the TX BoS CoC was 12/11/2017. Letters were distributed to SSVF applicants on 12/12/17.
- e. HMIS invoices have been sent, payments due December 15<sup>th</sup>
  - i. If you do not pay by 1/15/18, or have not made a payment arrangement by 1/15/18, THN will close off HMIS access.
- f. THN offices closed December 21<sup>st</sup> through January 2<sup>nd</sup>

#### Engaged and Informed: Keys to Successful Landlord Engagement and Eviction Prevention in Rural Communities

Market rate units are getting harder to secure for vulnerable clients. This workshop will be tailored to service providers, advocates, and housing locators who are interacting with landlords, both making the sell and sustaining units when relationships are challenged. Participants will practice interactions with landlords, including presentations to landlord groups, to ensure messaging is strong, engrained in the pitch, and framed effectively to get landlords to say yes and house your clients.

#### Coordinated Entry: Best Practices to Plan and Implement a Rural Coordinated Entry System

The federal government has set January 2018 as the date to have a coordinated entry system (CES) in place. Many rural communities are struggling with how to plan and implement a CES across a wide geographic area with few service providers. This workshop will guide communities through the initial design and planning for a CES, and offer recommendations on best practices from other rural communities. Through this workshop communities will produce a CES checklist of next steps.

#### Housing-based Case Management: Prioritizing Affordable Housing Provision for Clients

Many service providers have been trained to provide clinical, medically-focused supportive services for clients. It is our belief that housing is the foundation for stability and providers must be trained to understand and prioritize the affordable housing needs of clients to better help them achieve housing stability. This workshop provides essential tools and training to teach providers how to prioritize housing and includes key concepts such as low barrier program design, landlord engagement, and eviction prevention.

We want to work with communities that are interested in hosting these Housing Workshops. Please **join us** as we collaborate to increase housing stability and reduce homelessness for vulnerable communities.
