

Built for Zero and Texas Balance of State Continuum of Care (TX BoS CoC) Learning Collaborative Application

EXECUTIVE SUMMARY

Texas Homeless Network, as the CoC Lead Agency, has launched a TX BoS CoC Learning Collaborative in conjunction with [Community Solution's Built for Zero collaborative](#). This will be our second year continuing with this learning collaborative. The goal of the Learning Collaborative is to make Homelessness rare, brief, and non-recurring. The Learning Collaborative will accomplish this by facilitating communities to participate in a rigorous national change effort working to help a core group of committed communities end Homelessness led by Community Solutions. The Learning Collaborative does not include any funding or resources. Instead, it is an opportunity to improve a community's Housing Crisis Response System through a yearlong, peer-learning, expert-supported journey.

This will be our second year continuing with this learning collaborative. One of the communities that has participated in the collaborative had this to say about their experience in the Built for Zero Learning Collaborative:

“ Having CoC support during the BFZ process has been extremely valuable. Not only has the CoC support helped to keep us on track and hold us accountable, but we have been able to implement tools that make a difference not only in our goals for BFZ but in our efforts to make homelessness rare, brief, and non-recurring in our community. One example of this is creating the Diversion workflow in HMIS. As many CoCs experience, the housing we are able to provide through our HUD funding does not meet the need. Therefore, diversion can help us to better assist those experiencing homelessness connect to resources more quickly. We were doing some of this work before, however, the Diversion workflow allows us to track these efforts and have data to evaluate them. This would not have been possible without CoC support during the BFZ process, it is the first time I have experiencing providers' ideas being carried out in a tangible and impactful way.”

The TX BoS CoC will be able to support one additional community this year to participate in the Learning Collaborative. Teams from participating communities will learn from each other, from peer communities, and from experts in the field, while setting bold but achievable goals for themselves. Communities with all levels of expertise and capacity are encouraged to apply.

The Learning Collaborative will help participating communities adopt proven best practices, deploy existing resources more efficiently, and use real-time data to improve performance. Participating communities, with assistance from their peers and national experts, will establish their own ambitious goals for how to improve their Housing Crisis Response System. Participants will join in conference calls,

in-person meetings, peer site visits, hands-on technical assistance (TA), and webinars with experts and other communities in their collaborative.

Admission to the Built for Zero Collaborative is dependent upon meeting enrollment and attendance criteria set for by Community Solutions, funding from THN, and potential cost-share funding from community applicants.

ABOUT COMMUNITY SOLUTIONS

Established in 2011, [Community Solutions](#) is best known for its [100,000 Homes Campaign](#), which sparked a national movement that helped communities find homes for 105,580 homeless Americans in four years, and its campaign to end Veteran homelessness, [Zero: 2016](#).

Their mission is to end homelessness and the conditions that create it by helping communities become better problem solvers, so they can fix the expensive, badly designed systems that our most vulnerable neighbors rely on every day. As teams learn to work differently and rethink their existing resources, they find that they can help far more people escape homelessness and poverty than they once knew.

ABOUT BUILT FOR ZERO

Formerly known as Zero: 2016, the [Built for Zero](#) collaborative is a rigorous national change effort working to help a core group of committed communities to End Homelessness. Coordinated by Community Solutions, the national effort supports participants in developing real-time data on homelessness, optimizing local housing resources, tracking progress against monthly goals, and accelerating the spread of proven strategies. Through a national campaign-style strategy, the Built for Zero team is:

- Helping communities adopt proven best practices, deploy existing resources more efficiently, and use real-time data to improve performance
- Implementing transparent data and performance management for real-time improvement
- Engaging leadership from the government, private and philanthropic sectors in securing new resources for communities and removing policy roadblocks
- Connecting communities to one another through an online platform for innovation, knowledge capture and group problem solving

Since its start in January 2015, the Built for Zero collaborative has seen success, with more than 75,000 people housed by participating communities and seven communities having measurably and sustainably ended veteran homelessness. The collaborative has also assisted more than 50 participating communities to have real-time, by-name data on their local homeless populations, and more than 25

participating communities to drive measurable reductions in homelessness, month over month.

Built for Zero will involve hands-on coaching, implementation of transparent data and performance management, and a shared learning environment. Admission is by application only, and communities should use the application process to take inventory of their local resources and processes and to demonstrate their commitment to the task of getting to zero.

The journey to functional zero involves assembling a team that progressively grows as communities move through 3 cohorts. The first cohort is the By-Name List cohort. The By-Name List cohort's focus is to build a quality by-name list with reliable data, and involves a core team of a By-Name List manager, a community leader from the Local Homeless Coalition, a representative from the Coordinated Entry Planning Entity, and a representative from the VA. This team must be willing to travel and attend all in-person Learning Sessions, to the best of their ability.

The second cohort is Reduce to Zero. The goals during this phase are for communities to strengthen their leadership and Coordinated Entry System, to reduce the number of Veterans experiencing homelessness monthly, and to help communities achieve functional zero. The Reduce to Zero team may include additional members (such as representatives from the Public Housing Authority, HUD-VASH, local services etc.) that have the option to travel to a Learning Session if they wish.

The third and final cohort is Zero for All. The aim of this cohort is to sustain a state of functional zero and to expand to different homeless subpopulations, if desired. The hope is for all communities participating in Built for Zero to end their journey in this cohort.

EXPECTATIONS OF LEARNING COLLABORATIVE COMMUNITIES

Each community must agree to establish a team consisting of approximately two By-Name List cohort members, depending on the size and capacity of the community, and a larger "local" team to participate as the community moves through cohorts. By-Name List team members should include:

- A designated Community Leader recognized by the Local Homeless Coalition, which will be indicated on the application; and
- A by-name list manager.

One person may fulfill more than one role. Each By-Name List team member is expected to actively participate in Learning Collaborative in-person meetings, monthly phone conferences, and online forums. A representative from the TX BoS CoC and the VA will join each community's By-Name List team.

The larger group of "local" team members is not required to attend in-person Learning Sessions, but rather participate on the community level to accomplish the work of action planning, and implementing the action plan. Local team members may include, but are not limited to:

- The By-Name List team members;
- Persons with current or former lived experience of homelessness;
- Coordinated Entry Planning Entity Representatives;
- Representatives from Veterans Services (e.g. HUD-VASH, SSVF, VAMC officers);
- Homeless service providers;
- Street Outreach Program Administrators;
- Permanent Supportive Housing Administrators; and
- Local Homeless Coalition Members.

It's okay for the "local" team to fluctuate and grow over time, but By-Name List team members should plan to attend throughout the full timeline of the Learning Collaborative.

BY-NAME LIST TEAM MEMBER COMMITMENTS

By-Name List Team cohort members must agree to participate in the following learning activities over the period of March 2019-February 2020:

- Attend all in-person Learning Sessions;

- Complete pre-work and prepare clear goals before Learning Sessions;
- Meet between two and four times a month with your local team to share successes, identify challenges, and discuss next steps for practice and system improvements;
- Communicate with other teams and the Learning Collaborative facilitator and/or Improvement Advisor;
- Participate in conference calls with the Improvement Advisor once per month;
- Participate in a TX BoS CoC-wide call once per month;
- Participate and share learning on the online forum;
- Use data collected for progress reports to measure progress; and
- Share results on a regular basis with the Collaborative and the CoC General Membership.

RESOURCES AND SUPPORTS PROVIDED BY LEARNING COLLABORATIVE EXPERTS

Texas Homeless Network is a resource for TX BoS CoC communities participating in the Built for Zero Collaborative and will provide coordination between TX BoS CoC communities and data support. Community Solutions will provide materials, expertise, and forums for communities to accomplish the goals they set out for themselves as a part of the Built for Zero Collaborative. However, communities must be prepared to provide their team with the time, flexibility, support, and resources to accomplish these goals. More specifically, Community Solutions will:

- Organize, plan, and implement Learning Sessions, conference calls, and online forum;
- Provide access to homeless services experts, such as OrgCode and the Center for Social Innovation;
- Provide communities with the tools and instruction to use a custom performance management infrastructure to design and articulate community strategy, run tests of change, and drive measurable process to functional zero using a by-name list;
- Train participants on Quality Improvement and rapid cycle testing strategies; and
- Assist communities to build an Action Plan focused on testing specific change ideas throughout the Action Cycles.

WHICH COMMUNITIES CAN JOIN THE LEARNING COLLABORATIVE?

- Must have an active, recognized Local Homeless Coalition
- Must have an active, implemented Coordinated Entry Process & Planning Entity
- Must designate personnel to manage a By-Name List
- Must designate personnel to serve as a Community Leader
- Must be able to cover own travel costs
 - The By-Name List Team must commit to cover the expense of travel, lodging, food, transportation, and incidentals for each team member for the 2 off-site Learning Sessions. The TX BoS CoC estimates the total cost of attending both Learning Sessions at approximately \$2,500 per participant.
- Must demonstrate community commitment to working together to end homelessness

SELECTION PROCESS

One community will be selected to participate in the Learning Collaborative. Texas Homeless Network seeks to be inclusive of all eligible communities interested in participating. We will have a panel of Texas Homeless Network staff that will review, rank, and vote on the applications that are submitted. However, selection will be based, in part, on the capacity and ability of the community to participate,

funding availability, and evidence of commitment to working together to end homelessness.

SUBMITTING THE APPLICATION

Applications must be received electronically by Texas Homeless Network by 5:00 PM on February 1, 2019. Applications submitted after the deadline will be considered only if space is available. Coordinated Entry is a process developed to ensure that all people experiencing a housing crisis have fair and equal access and are quickly identified, assessed for, referred, and connected to housing and assistance based on strength and needs. Coordinated Entry is a critical component of the homeless crisis response system in the TX BoS CoC to make homelessness rare, brief, and non-recurring. The TX BoS CoC was required by HUD to implement coordinated entry on January 23, 2018.
