1. Please describe your personal and/or work experience with the population you would be representing in the designated seat, if elected.

I have been a police officer with the City of Killeen for almost 10 years (9 1/2) and I started and developed my departments Homeless Outreach Team in 2018. It started as a response to our growing homeless community, however it has morphed into a -sort of - Police Social Work position. I am an officer, but with the help of social work interns; developed a program that not only assists the homeless not be homeless; but developed an id recovery program, system or network of landlords to assist with housing, partnerships with mental health agencies and local hospitals, we even created our own transitional apartment program for our homeless families with children(used as an alternative to hotel stays) I have developed a homeless presentation I have shared with my police department, and I am currently in the process of developing a presentation for other police departments surrounding our community.

2. Please describe how you have participated in the TX BoS CoC in the past.

I am currently the seat 12 representative and have participated and contributed to numerous discussions to progress our TX Bos CoC. From new policies, governance, PIT processes, Strategic Planning, CoC competitions, and funding opportunities. These have been unique times dealing with Corona virus and working with the TX BoS CoC have been encouraging and enlightening. I only hope to continue to play a role in developing a process that his beneficial to us and those we intend to serve.
