1. Please describe your personal and/or work experience with the population you would be representing in the designated seat, if elected.

My experience is both personal and professional. I was in an abusive relationship for five years and after leaving the relationship financially it was difficult. At times my daughter and I were evicted several times. It was one of the most difficult times in my life. It seems like every time things came together so another emergency like transportation issues, job layoff, child's illness can be catastrophic when you are living paycheck to paycheck. I was working two jobs and attending college but struggled to keep a roof over our heads. This experiencing has helped me to understand my client's plight and struggle. I am able to let them know it is hard and it does not feel good and it seems hopeless but things can and will get better. Many days I think back to this experience and realize every circumstance is a lesson. These lessons led me to a profession that I feel called to be apart of daily. Although, I hope to one day be out of work.

2. Please describe how you have participated in the TX BoS CoC in the past.

I have participated in TX Bos CoC in the past by servicing as the LHC Chair for my area. I have also attended THN's conference for the past two years. I've assisted with facilitating the Point In Time Count for our area as well.

3. Please describe your experience, if any, working with the HUD Continuum of Care (CoC) Program or similar programs focused on ending homelessness (ESG, SSVF, PATH, and RHY).

I have experience working with the ESG, and CoC programs. I have a passion and true interest in helping to end homelessness and abuse. Both of these programs have been instrumental in helping with those issues in my community.
