COVID-19	 ESG-CARES Act Funds (ESG-CV)second allocation: We will know more about it after the TDHCA Board meeting in September. TDHCA is seeking more coverage across the state and working with agencies that are new to ESG. PHAs may not administer ESG. CSBG-CARES Act funds THN has a contract from TDHCA. THN has hired the ESG Specialist to provide support to the ESG-CV subrecipients in our CoC. 50% of funds will go to a Barriers Fund to help promote people's housing stability. THN is hiring the Barriers Fund Coordinator. NLIHC Funds The CoC's Community Investment Committee (CIC) met 2 weeks ago but had no new applications to consider. They will expand outreach to counties who haven't yet received an award. CIC may consider expanding the eligible counties. The CIC will vote on 3 additional members, and the Board will consider approving those 3 members at the 8/26 meeting. CoC Program competition – HUD may not require CoCs to hold competitions this year. Members discussed COVID in their communities	Staff will continue to administer these funds and monitor the status of the CoC Program competition.

CoC Strategic Plan	Staff drafted the plan and emailed it to SPC members and staff for feedback. The SPC will finalize a draft in August to be available for public comment in September and October. The SPC will finalize the plan in October and send it to the board for approval in November or December.	Staff will continue drafting the plan, seeking input, and preparing materials for public comment.
