2021 HOUSING INVENTORY COUNT GUIDE

HOUSING INVENTORY COUNT HISTORY

The Housing Inventory Count (HIC) is designed to be an accurate reflection of each Continuum of Care's (CoC) capacity to house homeless and formerly homeless persons. Each year, the U.S. Department of Housing and Urban Development (HUD) requires the housing inventory count to occur on the same night as the Point-in-Time (PIT) count.

- i. The count is on January 28th, 2021. The submission deadline is February 11th, 2021.
- ii. The HIC gathers information from
 - Temporary Housing: Emergency Shelter (ES) & Transitional Housing (TH)
 - Permanent Housing: **Rapid Re-housing** (RRH) & **Permanent Supportive Housing** (PSH)& **Housing Authorities** (HA)

GENERAL PROJECT INFORMATION (QUESTIONS 1-8)

- i. The organization name, project type, and project name will filter based on the current programs we have identified.

HUD requires that all organizations report on the HIC where they get their funding from. To simplify this process we only included HUD-VASH in your list of funding requirements. If you receive any other source of federal funds, please mark that in the comments section.

DETAILED PROJECT DEFINITIONS (QUESTION 11)

i. **HMIS:** Homeless Management Information System. If your project does use our HMIS system (ClientTrack), please mark yes.

VOUCHER INFORMATION (QUESTIONS 12-14)

This section pertains directly to your HUD-VASH vouchers. If you have other vouchers, please do not include those in this section. Every question in this section is required

- i. Total Number of HUD VASH Vouchers designated for your organization: This is the total number of VASH vouchers your organization has been allotted. Please only include the VASH vouchers.
 - This includes the vouchers in use and the ones that are not being used as of 1/28/21.
- ii. Vouchers IN USE by Veterans with Children: This is only the number of vouchers that are currently being used by veteran families (at least one adult with at least one child). HUD mandates that we separate vouchers based on the households they serve. If you do not have this information please submit a question via this link so we can follow up with you: https://thn.wufoo.com/forms/r17g8uol0je1f17/.
- iii. Vouchers IN USE by Veterans without Children: This is only the number of vouchers that are currently being used by single veterans, or adult couples without children. HUD mandates that we separate vouchers based on the households they serve. If you do not have this information please submit a question via this link so we can follow up with you: https://thn.wufoo.com/forms/r17g8uol0je1fl7/.
