Kristin Zakoor: To add to what Kyra said about the full count, HUD is highly discourging that method.

Kristin Zakoor: Due to health risks for volunteers and participants

Linda White: From a nursing stand point; I would recommend the least amount of contact as possible= observation only.

Kristin Zakoor: Thank you Linda for your expert opinion!

Norma Mercado 2: Shorten the survey and observation would be my choice

Marqus Butler: I say observation. If we're voting

Tavia Hatfield: out trauma safety hospital service area is at negative 18 beds so from a public health standpoint the Lubbock region is extremely unsafe right now for face to face contact

Norma Mercado: We are going to loose valuable information, I am hoping that HUD will consider that for funding

Tavia Hatfield: yes Norma I think it's a hard issue

Kristin Zakoor: Yes, Norma, they understand that this is a shift and we are losing valubale information and have said that they will not penalize communities.

KRAIG BLAIZE-FIERO: I have a feeling its goigng to be harder this year than normal just recruiting volunteers

Norma Mercado: I agree with loosing information but I am more concern about people being safe and limiting covid exposure

Emily Northrup: this is for unsheltered folks, correct? Will the sheltered count be the full survey?

Kristin Zakoor: That is correct, Emily. Sheltered will go on as normal.
