

# Texas Balance of State Continuum of Care

## Coordinated Entry COVID-19 Prioritization Standards

**Effective Date:** Beginning on September 1, 2020

**Policy:** In order to quickly house homeless individuals who are at increased risk for severe complications from COVID-19, Coordinated Entry will prioritize individuals with priority factors, as outlined in the table below, for all Rapid Re-Housing and Permanent Supportive Housing openings, regardless of funding source. The CE COVID-19 Prioritization Standards will end when health officials determine special measures to prevent the spread of COVID-19 are no longer needed. At the end of this period, Coordinated Entry Prioritization Standards will revert back to the existing standards.
