- **I. Welcome** Staff welcomed attendees, showed a photo collage of THN staff, and asked attendees to indicate their locations on a map.
- II. Data Snapshot LSA System-Wide Map (see attached presentation)
 - A. The Longitudinal Systems Analysis (LSA) Report provides data on homeless assistance to the U.S. Department of Housing and Urban Development (HUD).
 - B. Caveats: The LSA includes data from only Emergency Shelter (ES), Transitional Housing (TH), Rapid Re-Housing (RRH), and Permanent Supportive Housing (PSH) projects, not street outreach, homelessness prevention, or supportive services. The report is pulled from data in the Homeless Management Information System (HMIS), so it includes data on only projects that use HMIS. And the report looks only at households, not individuals.
 - C. The system-wide map show the paths that households have taken through the homeless crisis response system in the TX BoS CoC. From October 2019 -September 2020:
 - 1. 87% of households went directly from Coordinated Entry into emergency shelter (ES); 9% went to RRH; less than 1% to PSH; 4% to TH; and less than 1% to other.
 - 2. Only 24% of households exited to permanent destinations.
 - 3. 8% returned to the homeless crisis response system
 - D. The data can show where to focus efforts, for example, to increase exits to permanent housing (RRH and PSH).







What is the CoC Program?

CoC stands for Continuum of Care (Not coincidental that you see that term all over THN materials)

- The Continuum of Care (CoC) Program is designed to promote community-wide commitment to the goal of ending homelessness;
- to provide funding for efforts by nonprofit providers, states, and local governments to quickly re-house homeless individuals, families, persons fleeing domestic violence, and youth while minimizing the trauma and dislocation caused by homelessness;
- to promote access to and effective utilization of mainstream programs by homeless individuals and families;
- and to optimize self-sufficiency among those experiencing homelessness.










Texas Balance of State Continuum of Care (TX BoS CoC) Governance Structure



How it works (CliffsNotes Version)

- 1. HUD will release a Notice of Funding Availability a. This notice will establish the total amounts available for

 - i. Renewal Funding ii. New Project Funding (CoC Bonus & DV Bonus) b. The notice will establish the submission date of the
- The Independent Review Team, or IRT will review and score applications.
- THN staff will present recommendations to the CoC Board.
 THN submits approved Project Listing to HUD on behalf of the CoC.

Who Is Eligible to Apply?

In general, eligible applicants include **nonprofit organizations**, **states**, local governments, and instrumentalities of state and local governments. Public housing agencies, as such term is defined in 24 CFR 5.100, are eligible without limitation or exclusion. Tribes, tribal housing authorities, and for-profit entities are ineligible to apply for grants or to be subrecipients of grant funds. The 2021 Consolidated Appropriations Act expanded eligibility to Tribes, and Tribal Designated Housing Entities. This change would allow Tribes to create and maintain their own Continuums of Care.

Characteristic of a Strong Applicant

- Application is based on local data
 - PIT
 - HIC
- Applicant is working collaboratively with community stakeholders (LHC, Local Government, etc)
- Applicant is working towards racial equity and the Project Application reflects efforts to decrease the disparate impact of homelessness locally.
- Solicits and incorporates feedback from people with lived expertise, in Project Design, and Agency operations.

HUD Annual Requirements: CoC Collaborative Applicant Activities

CoC Program Registration

Registration opens the second Tuesday in January, per the CoC Program Registration Notice.

Housing Inventory Count (HIC)

Conduct the HIC during the last 10 days of January.

Grant Inventory Worksheets (GIW)

Review and ensure accuracy of the GIW record of all grants eligible for renewal within the CoC's geographic area.

Local Application Process

Conduct a local process to solicit, review, accept, and prioritize project applications.

CoC Program Competition

Submit the CoC Consolidated Application, which includes the CoC Application and the CoC Priority Listing containing all the project applications and their rankings.

QUARTER 3

Longitudinal Systems Analysis (LSA)

Submit LSA report in HDX 2.0 using Homelessness Mangement Information System (HMIS) data.

QUARTER 1

Point-in-Time Count (PIT)

Conduct the sheltered PIT count during the last 10 days of January. Conduct the unsheltered count at least every other year.

QUARTER 2

System Performance Measures (SPMs)

Submit SPM reports in HDX when notified by HUD; coordinate with ESG Program recipients.

PIT/HIC Data Entry

Submit PIT/HIC data in HDX, when notified by HUD.

Notice of Funding Opportunity (NOFO)

Read carefully the annual CoC Program Competition NOFO once released, prior to submitting funding applications to HUD.

Consolidated Plan

Participate in the Consolidated Planning process, submit the Consolidated Annual Performance and Evaluation Report (CAPER).

QUARTER 4

Grant Awards

When announced, review carefully the CoC Program awards and submit appeals by the published due date.

(Note: HUD's goal is to publish awards in Q4; award announcements sometimes occur in Q1 of the following year.)
