## 2022 HOUSING INVENTORY COUNT GUIDE

### HOUSING INVENTORY COUNT HISTORY

The Housing Inventory Count (HIC) is designed to be an accurate reflection of each Continuum of Care's (CoC) capacity to house homeless and formerly homeless persons. Each year, the U.S. Department of Housing and Urban Development (HUD) requires the housing inventory count to occur on the same night as the Point-in-Time (PIT) count.

- a) The count is on February 24<sup>th</sup>, 2022. The submission deadline is March 10<sup>th</sup>, 2022.
- b) The HIC gathers information from
  - Temporary Housing: **Emergency Shelter (ES) & Transitional Housing (TH)**
  - Permanent Housing: **Rapid Re-housing (RRH), Permanent Supportive Housing (PSH), and Other Permanent Housing (PH)**

#### 1.-3. Name, Email, Phone Number.

  - **If you are a Housing Authority that receives both EHV and VASH vouchers, you will be submitting each of these separately. That is why you cannot select both on this screen.**
