# **COVID-19 and the Upcoming Flu Season**

USICH discusses on page 11 of a <u>report on the federal response to COVID-19 for the homeless community</u> the impact of the co-occurrence of the upcoming annual flu season and COVID-19. It expresses concerns about the ability for individuals to distinguish which of the two they may have, increased demand on emergency rooms, and the contraction of both viruses at the same time.

USICH makes two recommendations to mitigate the impact of the co-occurrence of these two viral respiratory diseases in the homeless community:

- 1. Communities broadly promote and offer the seasonal flu vaccine to the homeless community and
- 2. Communities offer a single assay test for Influenza Type A, Influenza Type B, Respiratory Syncytial Virus (RSV), and COVID-19.

Not only will this serve to address the previously stated concerns, but it also provides a test run for distributing a COVID-19 vaccine to the homeless community when the vaccine is available.

#### **New TX BoS Data Committee**

Texas Balance of State (TX BoS) is looking for individuals interested in data! TX BoS wants to work hand in hand with community members to establish expectations around data collection, use, and upkeep. In order to do this, TX BoS has established a Data Committee to focus specifically on Texas Balance of State HMIS (Homeless Management Information System) data.

The purpose of the TX BoS Data Committee is to provide data-driven insight and education to multiple groups/stakeholders about homelessness in the Texas Balance of State. The TX BoS Data Committee would also be a way of providing feedback from HMIS end users on specific data matters such as HMIS Policies and Procedures, the HMIS Data Quality and Management Plan, data security, Point In Time Count information, and the TX BoS HMIS implementation.

The Data Committee had previously been put on hold due to COVID-19. We understand that this turbulent time means many people are stretched thin, and they may not have the capacity to participate like they might in normal times. We want to be transparent that committee members should be able to commit to 1-3 hours a month to the committee. This time would include webinars, calls, and reviews of data and policy documents.

#### **USDA Meals for Kids Site Finder**

To slow the spread of the new coronavirus (COVID-19), many schools have closed unexpectedly. To ensure that children who rely on free or reduced-price meals at school are able to get the nutrition they need, USDA is working with states to continue providing meals to students. Usually, the rules require that children gather and eat their meals on site. However, due to the exceptional circumstances of this public health emergency and the need for social distancing, USDA was able to make temporary changes so that meals may be taken home, and parents or guardians may pick meals for their children if the state allows. Families can use this tool to find directions to nearby sites as well as hours of operation and contact information.

# Staff Recommendations

The following are resources TX BoS CoC Lead Agency staff have found that we believe would be beneficial to your local efforts to make homelessness rare, brief, and one-time:



We are please to offer two recommendations this month, the first coming from our Racial Equity Intern, Giovanna DiNapoli:

"Throughout the span of my internship with Texas Homeless Network, I have centered my focus on getting acquainted with THN's systems, reading and developing research,

establishing a racial equity toolkit and recommendations, and writing up one-page reports.

The first one-pager I am sharing details takeaways from the Supporting Partnerships for Anti-Racist Communities (SPARC) Report on the intersection of race and homelessness. I encourage taking time to reflect on how the recommendations from the SPARC Report can be applied towards establishing racial equity in your work duties and daily life."

At the Texas Interagency Council on Homelessness (TICH) meeting on Tuesday, July 21, the Texas Education Agency announced that they had an <u>FAQs regarding students</u> experiencing homelessness and <u>COVID-19</u> to help Local Education Agencies (LEAs). We felt this information is also important for any providers serving children and/or families.

We also learned about the presence of Community Services Block Grant CARES Act (CSBD-CV) funding across Texas. You can read more about those <a href="here">here</a>.
