Texas Homeless Network is the lead agency for the <u>Texas Balance of State Continuum of Care (TX BoS CoC)</u>. The TX BoS CoC is a group of stakeholders that collaboratively plan and operate the CoC and a range of housing and services to prevent and end homelessness. The TX BoS CoC covers 215 counties and includes 24 Local Homeless Coalitions (LHCs) that plan, deliver, and evaluate local systems.

Kraig recommends -

New Housing and HIV Data Integration Toolkit

The "Sharing and Integrating HIV Client Data Across Provider Organizations to Improve Service Coordination" toolkit was designed to help organizations interested in sharing data across the HIV and housing sectors to improve care coordination and outcomes for people with HIV who experience housing instability. It was developed as a way to share lessons learned with others who are considering replicating similar efforts and highlights critical decision points and activities to consider in sharing data across service providers. The toolkit was produced by the RAND Corporation, with support from the Health Resources and Services Administration (HRSA) Ryan White HIV/AIDS Program Special Projects of National Significance (SPNS) Program, HUD's Office of HIV/AIDS Housing (OHH), and the Minority HIV/AIDS Fund.

Andrew recommends -

<u>Integrating Persons with Lived Experiences in our Efforts to Prevent and End Homelessness</u>

"SNAPS partnered with young people with lived experiences of homelessness to develop the Youth Homelessness Demonstration Program (YHDP), from its initial planning and ongoing through its implementation. Young people identified the key concepts that were included in the Notice of Funding Availability (NOFA), helped review project applications, and provided technical assistance to the selected sites. This partnership continues to be crucial to the success of the program, and our goal is to apply those lessons to all our work."
