


Texas Balance of State Continuum of Care News July 2020



TX BoS CoC Public Comment Portal

- Reallocation Policy and Procedure for Continuum of Care Program Funds in the Texas Balance State Continuum of Care
- Conditional Inclusion Policy and Procedure for Continuum of Care Program Funds in the Texas Balance State Continuum of Care

The Public Comment Portal lists the submission deadline for each item up for consideration.

New TX BoS Data Committee

Texas Balance of State (TX BoS) is looking for individuals interested in data! TX BoS wants to work hand in hand with community members to establish expectations around data collection, use, and upkeep. In order to do this, TX BoS has established a Data Committee to focus specifically on Texas Balance of State HMIS (Homeless Management Information System) data.

The purpose of the TX BoS Data Committee is to provide data-driven insight and education to multiple groups/stakeholders about homelessness in the Texas Balance of State. The TX BoS Data Committee would also be a way of providing feedback from HMIS end users on specific data matters such as HMIS Policies and Procedures, the HMIS Data Quality and Management Plan, data security, Point In Time Count information, and the TX BoS HMIS implementation.

The Data Committee had previously been put on hold due to COVID-19. We understand that this turbulent time means many people are stretched thin, and they may not have the capacity to participate like they might in normal times. We want to be transparent that committee members should be able to commit to 1-3 hours a month to the committee. This time would include webinars, calls, and reviews of data and policy documents.

ESG CARES Act Recommendations Submitted

The TX BoS CoC Board has approved the final recommendation to the Texas Department of Housing and Community Affairs (TDHCA) for Emergency Solutions Grant (ESG) CARES Act (CV) Round 1 Funds.

Recommendations are conditional. Recommendations will be presented to the TDHCA Governing Board, pending the completion of the previous participation and recommendation of the TDHCA Executive Award Review Advisory Committee. TDHCA makes the final decision regarding awards. Once TDHCA informs THN of their final subrecipient selection for agencies in the TX BoS CoC we will share that information with all of you.

The 14 agencies who are being recommended will provide ESG CV Funds to 46 counties in the TX BoS CoC, 32 or 70%, of these counties are counties that are not currently served by ESG funding. The recommendation can be found here.



2020 Census Workers to Count Population Experiencing Homelessness in September

The U.S. Census Bureau has announced the new schedule for counting people experiencing homelessness in the 2020 Census. The operation was originally scheduled for March 30, March 31 and April 1, but health and safety concerns with COVID-19 forced us to delay these activities.

Between September 22 and 24, the Census Bureau now plans to send specially trained census takers to count people at shelters, soup kitchens, regularly scheduled mobile food vans, and locations previously identified by the Census Bureau where people are known to sleep outdoors (like under bridges) and at all-night businesses (such as transit stations and 24-hour laundromats). People experiencing homelessness will be counted where they are staying when census takers visit between September 22-24.

HUD-Veterans Affairs Supportive Housing (HUD-VASH) Voucher NOFA

This notice announces the availability of \$50 million in HUD-Veterans Affairs Supportive Housing (HUD-VASH) funding that will support approximately 6,000 new HUD-VASH vouchers. These vouchers are administered in partnership with the U.S. Department of Veterans Affairs (VA), and enable homeless veterans and their families to access affordable housing with an array of supportive services. Public Housing Authorities are the only entities eligible to apply.

New Validated Early Childhood Self-Assessment Tool for Shelters Released

Children make up 29% of the population of people experiencing sheltered homelessness in the TX BoS CoC. The Administration for Children and Families recently released a self-assessment tool for shelters. The purpose of the tool is "to guide shelter staff in creating safe, developmentally appropriate environments for infants, toddlers, preschoolers, and their families who are experiencing homelessness."
