#### Persons with Lived Experience of Homelessness

Texas Homeless Network (THN), as the lead agency of the TX BoS CoC, is recruiting individuals with current or recent experience of homelessness to serve on an advisory workgroup. This Persons with Lived Experience (PLE) Workgroup, will provide Texas Homeless Network staff and the TX BoS CoC Board with valuable input on homeless services within the TX BoS CoC.

### Youth Action Board (YAB)

Texas Homeless Network (THN), as the lead agency of the TX BoS CoC, is recruiting for a Youth Action Board (YAB). The YAB is a paid advisory program for youth and young adults with lived experience of homelessness, foster care system, juvenile justice systems, and other-systems.

YAB members will collaborate with THN to help end youth homelessness across the TX BoS CoC and vote to select one delegate to represent youth and young adults experiencing homelessness on the TX BoS CoC Board.

Applicants must be 16-24 years old, have lived experience of homelessness, foster care or juvenile justice systems and live within a county in the TX BoS CoC.

## **HOME-ARP Program**

The <u>HOME Investment Partnerships-American Rescue Plan Program (HOME-ARP)</u> provides funding to HOME participating jurisdictions (states and certain counties and cities) to reduce homelessness and increase housing stability. <u>Eighteen jurisdictions in the TX BoS CoC</u> (TX-607) plus the State received HOME-ARP funds to provide housing and services to people experiencing homelessness, people at risk of experiencing homelessness, and other vulnerable populations.

Jurisdictions must complete a HOME-ARP Allocation Plan that says how HOME-ARP funds will be used in their communities. Jurisdictions are required to consult with certain groups, including CoCs and homeless services providers.

- <u>Local Homeless Coalition (LHC)</u> members and homeless services providers have important local information and data for jurisdictions, so look for opportunities to give input, or contact your community development department.
- THN also encourages communities to talk with individuals with lived experience of homelessness, people with disabilities, as well as Black, Indigenous, and Latine

people and other people of color, who are disproportionately represented in the homeless population.

HUD has created a <u>Discussion Guide for HOME-ARP Consultation Meetings</u>.

Several groups have advocated for using HOME-ARP funds in specific ways. See ideas on <u>strategies for using HOME-ARP</u>; <u>prioritizing permanent supportive housing and affordable housing</u>; <u>addressing racial disparities</u>; and <u>assisting families involved in the child welfare system</u>.

The Street Outreach Program (SOP) provides street-based services to runaway, homeless, and street youth who have been subjected to or are at risk of being subjected to sexual abuse, prostitution, sexual exploitation, and severe forms of human trafficking in persons. These services, targeted in areas where street youth congregate, are designed to assist such youth in making healthy choices and providing them access to shelter as well as basic needs, including food, hygiene packages, and information on a range of available services.

## New Onboarding Toolkits for ESG-Funded Program Staff



Emergency Solutions Grants (ESG) recipients and sub-recipients have quickly scaled up rapid re-housing (RRH) and targeted prevention efforts, including repositioning existing staff, adding new staff, and/or rapidly refilling vacated positions due to COVID-19. New

staff may not have received in-depth training on the best practices that promote successful outcomes for people experiencing homelessness.

Each of the new Onboarding Toolkits provides a series of informational training videos and resources to orient and train new or transitioning staff who serve as Grant Administrators, Program Directors, RRH Supervisors, and RRH Case Managers.

## **Staff Recommendations**

The following are resources TX BoS CoC Lead Agency staff have found that we believe would be beneficial to your local efforts to make homelessness rare, brief, and one-time:. This month's recommendations come from Jen Beardsley, Local Homeless Coalition (LHC) Coordinator.

- The Substance Abuse and Mental Health Services Administration (SAMHSA) released a <u>Supplemental Security Income (SSI)</u> and <u>Social Security Disability Insurance (SSDI)</u> <u>Applicant Self-Help Toolkit</u> to help guide applicants through the application process when they do not have access to an SSI/SSDI Outreach, Access, and Recovery (SOAR)-trained provider. The guide is available in 16 languages. SAMHSA's SOAR program trains service providers and volunteers how to assist eligible adults who are experiencing or at risk of homelessness and have a serious mental illness, medical impairment, and/or co-occurring substance use disorder apply for SSI and SSDI benefits. - Guide to Methamphetamine Use, Treatment, and Housing Considerations for
   People Experiencing Homelessness gives supportive housing providers guidance
   on harm-reduction approaches to support people experiencing homelessness and
   methamphetamine use disorder transitioning into supportive housing. The
   Homeless Housing and Resource Center, a collaboration between the Substance
   Abuse and Mental Health Services Administration (SAMHSA) and Policy Research
   Inc. (PRI), offers the guide in English and Spanish.
