# 2021 Fair Market Rents (FMRs)

The U.S. Department of Housing and Urban Development (HUD) released 2021 Fair Market Rents (FMRs), which will be effective starting Thursday, October 1, 2020. The Texas Department of Housing and Community Affairs (TDHCA) Emergency Solutions Grants (ESG) annual fund sub-recipients must ensure they use the most updated FMRs released by HUD. The FMR waiver for ESG annual funds on new leases granted by HUD expires **September 30, 2020**.

FMRs are available at <a href="https://www.huduser.gov/portal/datasets/fmr.html">https://www.huduser.gov/portal/datasets/fmr.html</a>. For those ESG annual fund sub-recipients in places with Small Area FMRs, please use the FMR information for other programs; Small Area FMRs cannot be used for ESG.

For ESG Coronavirus Aid, Relief, and Economic Security (CARES) sub-recipients, the FMR requirement has been waived. However, the rent reasonableness requirement still applies to program participants receiving rapid re-housing and homelessness prevention.

# <u>Coming Soon!</u> <u>Texas Homeless Network Brings Barrier Fund to TX BoS CoC</u>

The Texas Homeless Network is thrilled to announce that staff are working to establish a Barriers Fund that will provide financial resources to the Texas Balance of State Continuum of Care. Funded by the <u>Community Services Block Grant CARES Act State Discretionary Funds</u> (CSBG-CV-D), the Barriers Fund will provide direct services to low-income households that are homeless or at-risk of homelessness.

# Join the TX BoS Data Committee

Texas Balance of State (TX BoS) is looking for individuals interested in data! TX BoS wants to work hand in hand with community members to establish expectations around data collection, use, and upkeep. In order to do this, TX BoS has established a Data Committee to focus specifically on Texas Balance of State HMIS (Homeless Management Information System) data.

The purpose of the TX BoS Data Committee is to provide data-driven insight and education to multiple groups/stakeholders about homelessness in the Texas Balance of State. The TX BoS Data Committee would also be a way of providing feedback from HMIS end users on specific data matters such as HMIS Policies and Procedures, the HMIS Data Quality and Management Plan, data security, Point In Time Count information, and the TX BoS HMIS implementation.

The Data Committee had previously been put on hold due to COVID-19. We understand that this turbulent time means many people are stretched thin, and they may not have the capacity to participate like they might in normal times. We want to be transparent that committee members should be able to commit to 1-3 hours a month to the committee. This time would include webinars, calls, and reviews of data and policy documents.

# Staff Recommendations

The following are resources TX BoS CoC Lead Agency staff have found that we believe would be beneficial to your local efforts to make homelessness rare, brief, and one-time:



This month's recommendation come from Kraig, our CoC Programs Assistant:

## **National Dislocated Worker Grants**

"U.S. Department of Labor National Dislocated Worker Grants (DWGs) are discretionary grants awarded to provide employment-related services for dislocated workers. The Department funds two types of DWGs: Disaster Recovery and Employment Recovery. DWGs are time-limited funding assistance in response to major economic dislocations or other events that cause significant impact on states and local areas that exceed the capacity of existing formula funds and other relevant resources to address. Projects funded with DWG resources must be aligned with existing state and local strategic priorities, resources, and programs and not operated as stand-alone projects. Applicants should design and carry out DWG projects to operate in alignment with other state and local programs, including Rapid Response, layoff aversion, and the formula Dislocated Worker program and focused on addressing employment and training needs in states and local areas."
