The TX BoS CoC is a group of stakeholders that collaboratively plan and operate the CoC and a range of housing and services to prevent and end homelessness. The TX BoS CoC covers 215 counties and includes 28 Local Homeless Coalitions (LHCs) that plan, deliver, and evaluate local systems.

Coordinated Entry COVID-19 Prioritization Standards

The TX BoS CoC Board approved time-limited Coordinated Entry COVID-19 Prioritization Standards. Prioritization standards ensure households seeking assistance through Coordinated Entry with the most severe service needs and vulnerabilities are prioritized for housing first, and these standards include COVID-19 risk factors. All Rapid Re-

Housing and Permanent Supportive Housing openings regardless of funding source will use these prioritization standards between **September 1**, **2020 and February 28**, **2021**.

As more information about COVID-19 becomes available, the TX BoS CoC will continue to evaluate and adjust prioritization policies based on evolving information and circumstances.

Join the TX BoS Data Committee

Texas Balance of State (TX BoS) is looking for individuals interested in data! TX BoS wants to work hand in hand with community members to establish expectations around data collection, use, and upkeep. In order to do this, TX BoS has established a Data Committee to focus specifically on Texas Balance of State HMIS (Homeless Management Information System) data.

The purpose of the TX BoS Data Committee is to provide data-driven insight and education to multiple groups/stakeholders about homelessness in the Texas Balance of State. The TX BoS Data Committee would also be a way of providing feedback from HMIS end users on specific data matters such as HMIS Policies and Procedures, the HMIS Data Quality and Management Plan, data security, Point In Time Count information, and the TX BoS HMIS implementation.

The Data Committee had previously been put on hold due to COVID-19. We understand that this turbulent time means many people are stretched thin, and they may not have the capacity to participate like they might in normal times. We want to be transparent that committee members should be able to commit to 1-3 hours a month to the committee. This time would include webinars, calls, and reviews of data and policy documents.

2020 Census: Information for CoCs

We appreciate HUD and the Continua of Care (CoCs) providing additional locations and addresses for the Service-Based Enumeration (SBE) operation of the 2020 Census. However, we caution against waiting too late to provide location information. Any delays will increase the risk of not counting the SBE addresses due to the lack of adequate time for staffing and logistics planning for significant additions.

If your agency has information to provide to the Area Census Offices (ACOs), please do so **now** by emailing <u>dcmd.group.quarters.eresponse@census.gov</u> (the primary email address) or <u>dcmd.group.quarters@census.gov</u> (another active address we shared in HUD's Office Hours on Friday, September 4).

September 18, 2020 is the last date to submit address information for the 2020 Census SBE operation in order to include the address in our 2020 Census frame. Once the ACO stops adding cases, we will not be able to include those locations in the 2020 Census. It is important that service-based locations reach out to the Census Bureau immediately via the dcmd.group.quarters.eresponse@census.gov to ensure they get counted.

Continua of Cares and providers will be contacted by their <u>Area Census Office</u> (ACOs) to confirm service-based enumeration processes and locations by September 11.

- <u>Service-Based Enumeration</u> (shelters, soup kitchens, etc.) counts will take place between <u>September 22-24</u>
- Targeted Non-Sheltered Outdoor Locations (unsheltered) counts will take place the **night of September 23 into the morning of September 24**
 - Providers are encouraged to inform their clients of the Census dates, and that enumerators will wear bright orange vests during the unsheltered count

ACOs will be adding service-based enumeration locations up until September 21, so be sure to be in contact with your ACO to establish your site as an enumeration location if you have not been contacted by **September 11**.
