## CoC Competition Updates

What a time to be a part of this work!

THN has been working hard on the application processes for the Supplemental and Annual Notices of Funding Opportunity(NOFO) for the Continuum of Care (CoC) Program. No one at THN has ever managed two of these application processes simultaneously before, and they are different from anything HUD has ever asked. We thank you for your patience and wanted to make sure you knew some critical details about both of these processes

### The Supplemental NOFO:

- Will fund a lot of new activities, that previously have been out of reach for many communities.
- Applicants must follow the CoC Priorities in the CoC Comprehensive Plan to Address Severe Service Needs (CoC Plan). We are seeking feedback on that Plan now! [Please visit the Public Comment Portal to view the plan and access the feedback form.](#)
- The CoC will host another input session on August 10, [register for that by clicking this link.](#)
- The Application is projected to **open August 26th, and close September 11**, but applicants are encouraged to begin work engaging partners and Persons With Lived Experience (PWLE) on Project Design now!
- Applicants are required to leverage Housing or Healthcare resources- for more details on an advantageous way to structure those relationships, please see the CoC Plan
- The Detailed Instructions for the Supplemental NOFO are not yet out, [check this page for updates.](#)
- All new projects must apply through the Supplemental NOFO, while the Annual process is reserved for renewal projects only.

### The Annual NOFO:

- Has the shortest turn-around in memory, HUD gave CoCs **60 days** to complete the entire process which will significantly accelerate the process for applicants and the CoC to complete the CoC Application. The Application Process is projected to **open August 15th, and close August 31st.**

- The Detailed Instructions are not yet out, making the e-snaps portion of the application process challenging.
- The CoC will only accept applications for Projects that were previously funded in FY2021, Applications for new funding must be submitted through the Supplemental NOFO.

## **THN Evaluation VISTA**

Join Texas Homeless Network's Systems Change team in strengthening local homeless service systems by implementing local Coordinated Entry evaluation processes.

As the THN Evaluation VISTA, you will create a project plan for the pilot Coordinated Entry (CE) evaluation process with the Systems Change Manager to implement locally in Coordinated Entry Planning Entity (CEPE) regions. Once you have completed the project plan, you will engage CEPE regions to implement pilot evaluation processes in a few communities across the Texas Balance of State Continuum of Care (TX BoS CoC) to increase effectiveness of CE and better serve individuals and families experiencing homelessness. You will do so by: 1) selecting pilot regions and familiarizing with their current CE communication and evaluation engagement, 2) conducting training and technical assistance to local service providers, 3) evaluating feedback from pilot implementation, 4) creating implementation guidelines and training frameworks for broader local implementation, and 5) co-facilitate feedback process for CEPE pilot regions to give feedback for continued improvement and sustainability.

## **Funding & Other Opportunities**

### **Child Care Expansion Initiative**

Texas Workforce Commission (TWC) is launching a new initiative to build the supply of high-quality child care across Texas! Funding will soon be available to expand existing child care businesses and launch new ones. Organizations, businesses, or individuals are eligible to apply if the child care will serve an area where there is not enough child care, if the child care will serve employees' children, or if the child care will care for infants ages 0 to 17 months.

#### **SOAR Orientation**

Join THN Staff and Experts from Policy Research Associates Inc. with the Substance Abuse and Mental Health Services Administration (SAMHSA) SSI/SSDI Outreach Access and Recovery (SOAR) SOAR TA Center to talk about SOAR, what it is, why it is important, and what you can do to skyrocket SSI/SSDI approval rates in your community. Income Stabilization is an important part of a person's housing stability plan and people with longer-term experiences of homelessness are often at a distinct disadvantage when seeking SSI/SSDI. SOAR is designed to expedite access to Social Security disability benefits for individuals who are experiencing or at risk of homelessness and who have serious mental illness and/or co-occurring substance use disorders or other physical disabilities. Fifty states, including the District of Columbia, now participate in the national SOAR Technical Assistance Initiative which is sponsored by the Substance Abuse and Mental Health Services Administration (SAMHSA).

Participants will learn about SOAR, an update to the Texas roll-out of this initiative, and how Applicants to the Supplemental Notice of Funding Opportunity (SOAR) can fund SOAR staffing costs. (**See the Important Dates Section Below for Registration Link**)

#### **2022 Housing Solutions Workshop**

The Housing Solutions Lab is pleased to invite applications for the **2022 Housing Solutions Workshop**. Hosted in collaboration with Abt Associates and the Lincoln Institute of Land Policy, the six-week virtual workshop provides training for small and midsize city housing leaders to develop comprehensive and balanced housing strategies that improve housing affordability and address other housing challenges.

Eligible applicants include small or midsize cities or counties in the United States (population between 50,000-500,000) that have not recently developed a comprehensive local housing strategy.

The Workshop will include asynchronous learning, group discussions with peer localities, and working sessions for each city to focus on its specific housing challenges and develop a policy toolkit.

## Staff Reccomendation

### Supporting Immigrant and Migrant Students Experiencing Homelessness

SchoolHouse Connection has identified **strategies to support students who are immigrants or migrants and who are living in homeless situations**. The blog post

discusses students' educational rights and McKinney-Vento Act eligibility for homeless assistance. It lists actions tailored to specific subpopulations--young children, Kindergarten through 12th grade students, higher education students, and unaccompanied youth. And it provides examples from communities that have successfully implemented strategies that support students.
