The TX BoS CoC is interested in Applicants that can demonstrate a commitment to leveraging private Housing and Healthcare resources, such as Mainstream Vouchers or reduced/no-cost healthcare for participants in HUD programming as well as applicants that can demonstrate the need for Projects targeted for Survivors of Domestic Violence

In general, the CoC program will fund **Rapid Re-Housing, Permanent Supportive Housing, Joint Transitional Housing & Rapid Re-Housing (TH/RRH), HMIS, and Coordinated Entry**. August 19, 2022

THN is now accepting **Bonus** funds applications in the FY2022 Annual CoC Program Competition. Eligible applicants include **current** Recipients of CoC Program Funds seeking to **expand** their existing project and **providers serving survivors of domestic violence** seeking to establish **new** projects utilizing **DV-Bonus** funds. See the table above for the RFP and related materials. Bonus fund applications are due 8/31/22 by 11:59:59 PM.

August 17, 2022

THN is now accepting applications from **current** Recipients of CoC Program Funds that are eligible for **renewal** in the FY2022 Annual CoC Program Competition. See the table above for the RFP and related materials. Renewal applications are due 8/31/2022 by 11:59:59 PM.

August 12, 2022

We're continuing to work on the application processes for the Supplemental Notice of Funding Opportunity (NOFO) and the Annual NOFO for the Continuum of Care (CoC) Program. Developing both processes and receiving new information from HUD almost daily, has meant changing our processes to give the most opportunities to apply for funding. So, below are some updates just since we posted information in the CoC newsletter last Monday.

The Supplemental NOFO:

- Applicants must follow the CoC Priorities in the *CoC Comprehensive Plan to Address Severe Service Needs* (CoC Plan). [Please visit the Public Comment Portal to view the plan](#). The CoC Plan will be reviewed by the Persons with Lived Experience Workgroup next week and by the CoC Board on 8/24.
- Applicants are required to leverage housing or healthcare resources. For more details on how to structure those relationships, please see the CoC Plan.
- The CoC will consider project applications from organizations that have not previously administered CoC Program Funding! If you have not previously administered CoC Program Funding, **you are encouraged to sign up on the listserv for updates**, ask questions as needed, and we hope that you apply!
- The CoC's Request for Proposals (RFP) and "local application" is projected to **open on August 26th and close on September 11**, but applicants are encouraged to begin engaging partners and Persons With Lived Experience (PWLE) on project design now.
- **NEW!** HUD has posted Detailed Instructions for project applications. Those instructions will tell you how to apply in e-snaps (HUD's online portal). See the [Detailed Instructions for the Project Application on HUD.gov](#) and on the [HUD Exchange](#).

The Annual NOFO:

- **NEW!** The CoC will release two RFPs and applications: Please note that these are "staged" applications meaning that all scored materials are due by the deadline prescribed by the NOFO (August 31st) and non-scored materials will be due later in September
 - RFP for Renewal Projects that are eligible for renewal in 2022
 - RFP for New Projects that are applying for "CoC Bonus" funds (only Expansions of Renewal Projects will be eligible to apply) and for "DV Bonus" funds (new projects for Victim Service Providers may apply).
- HUD gave CoCs 60 days to complete the entire process. The CoC's RFPs and "local applications" are projected to **open on August 17th for Renewals and August 19th for Bonus Projects and close on August 31st**.
- The CoC will consider project applications from organizations that have not previously administered CoC Program Funding! If you have not previously administered CoC Program Funding, **you are encouraged to sign up on the listserv for updates**, ask questions as needed, and we hope that you apply!
- HUD has not posted Detailed Instructions for project applications yet. Those instructions will tell you how to apply in e-snaps (HUD's online portal). Watch for [Renewal Project and New Project Detailed Instructions on HUD.gov](#) and on the [HUD Exchange](#).

June 22, 2022

On June 22, 2022, HUD released a Supplemental Unsheltered and Rural Notice of Funding Opportunity (NOFO). This funding opportunity is very similar to the CoC Program, in fact, it appears to directly mirror the process of the CoC Program with a few added requirements. THN staff are evaluating the requirements for this Opportunity and are designing a process that we hope will make our CoC as competitive as possible. Unfortunately, that translates into some uncertainty for the immediate short-term, as we don't know the full extent of the impact to the existing CoC Program Local Application Process. Additionally, on June 23, HUD released the FY2022 CoC Grant Inventory Worksheet, and THN staff are preparing for the upcoming release of the CoC NOFO and imminent CoC Competition. Rest assured, THN is working to develop a process that is as efficient as possible for both funding opportunities.
