


Understanding the Influence of Social Integration on the Formerly Homeless



Value Impact Builds FOCUS OF TODAY'S DIALOGUE: To understand and contemplate the value of housing and why and how the type of housing impacts self-sufficiency, quality of life, and housing retention and builds a sense of community.

Study on Housed Formerly Homeless:

To Understand the Influence of Social Integration on the Formerly Homeless

Problem: As homelessness continues to increase, the current approach has not met expectations to mitigate the risk of returning to homelessness

Result: People return to homeless; little development of social networks; isolation

Social Implications: Time to re-evaluate our approach and understand how the formerly homeless want to be integrated into the community; increase sense of community

Future Goal: Housing sustainability, increased well-being, self-sufficiency, sense of community





Design Framework

- What: A qualitative phenomenological design
- Why: Exploring a current phenomena (Creswell, 2013)
- **How:** Gather data through interviews, based on the experiences of the participants
- **Who:** Housed, Formerly Homeless

Target Population







- 15 formerly homeless individuals Southwest Texas
- (15/724)
- Housed between 24 and 60 months
- In a Housing First program
- With a section 8 voucher

Significance of Study

Address the gap in social psychology literature - how do the formerly homeless want to be socially integrated within the community

Reduce number of People returning to homelessness

Social Integration Housing Housing Sustainability

The results of the study have the potential to enhance current strategies and make a significant contribution to the future of how homelessness is addressed. If social integration in concert with housing can improve the long-term sustainability of those who are housed, increased socialization may have the potential to reduce the number of people who leave their housing and return to homelessness





Qualitative Survey Tool Questions

RQ1.1: What purpose does a sense of membership in one's community play in fostering successful integration of the formerly homeless individuals into their community and what are the supporting interventions?

RQ1.4: What role does an emotional connection with one's community play in fostering successful integration of housed, formerly homeless individuals into their community and what are the supporting interventions?

RQ1: How do sociallyfocused interventions influence a person's sense of community and support the social integration of the formerly homeless into the community?

RQ1.2: What purpose does the fulfillment of personal needs within one's community play in fostering successful integration of housed, formerly homeless individuals into their community and what are the supporting interventions?

Subdivided into 4 questions:

Assumptions

1. Participants will provide honest answers 2. Homeless deal with loss of housing and cisaffiliation from social networks 3. Those housed between 24 and 60 months will have increased social integration 4. Housing First has not met expectations for increased social integration

Results – RQ1.1: Sense of Membership




- Housing was multi-dimensional
 - Face value was shelter
 - Defines a community for members
- Psychosocial need to be in caring environment with peers
 - To be able to engage with people with common interests
- Senior housing
- Walkable
- Green Spaces
- Activities to participate in
- Miss their old friends
- No sense of membership

RQ1.1: What purpose does sense of membership a in one's community play in fostering successful integration of the formerly homeless individuals into their community and what are the supporting interventions?



Results: RQ1.2 Needs Fulfilment



- Housing changed their life
- Wanted quality housing
 Vs. just a roof
- Rational choice to conform
- Lack of transportation
- Lack of peers
- Valued housing over homelessness but wanted quality housing
- Needs fulfillment of housing accomplished but not of quality housing
- Having housing can not assume social engagement

NEEDS FULFILLMENT

RQ1.2: What purpose does the fulfillment of personal needs within one's community play in fostering successful integration of housed, formerly homeless individuals into their community and what are the supporting interventions?





Results: RQ1.3 Sense of Influence

- Lack of quality housing = no community attachment
- Did not know neighbors
- Isolation
- No attachment to community
- No interaction with neighbors
- In fear of loosing voucher and returning to homelessness
- Did not know how they could move forward
- No interaction with support network

SENSE OF INFLUENCE

RQ1.3: .1What purpose does influence in one's community play in fostering successful integration of housed, formerly homeless individuals into their community and what are the supporting interventions?



Results: RQ1.4 Emotional Connection



No attachment to the Community where they lived

Did not have anything in common with their neighbors

They remembered what it was like to have an emotional connection with friends

One had a connection with the children – teach them values

Experienced little emotional connection

Limitations of the Study

- Increase population size to trend data
- Potential interview bias was mitigated by use of phone interviews
- Future studies may consider different demographic data: foster youth, women with children and veterans.
- Phones interviews increased participation and enforced consistency
- PSCO survey tool was designed for this study and will be available for use
- Data presented to peers during process to validate data integrity



Recommendations for Future Research

- Data collection from same target population from different sources using same requirements
- Data collection from different cohorts of homeless – Foster Care, Veteran's, Families with Children, using same requirements
- Industrialize the qualitative tool and design comparable quantitative tool






New Lens for looking at homelessness in he 21st century:
