

FY25 CoC Program Competition Updates

January 9, 2026

- Update: HUD Reopens FY24-25 CoC NOFO for Renewals Only
- **Important:** This is NOT an open competition for new projects. No new applications will be accepted at this time.
- On **December 23, 2025**, a federal court ordered HUD to reopen the **FY24-25 CoC NOFO** for processing **eligible renewal projects only**. HUD will follow this order until further notice.
 - This reopening is **limited to processing eligible renewal projects** under the FY24-25 NOFO, listed in the [FY25 Grant Inventory Worksheet](#).
 - HUD **cannot obligate funding or grant awards** at this time.
 - **New projects are not eligible under this process.**
 - If the court order changes, HUD will implement the **new NOFO issued December 19, 2025 (FR-6901-N-25)** and provide updated instructions.
- HUD expects to complete internal reviews and identify selections for **eligible renewal projects** by late March 2026, consistent with the court order. This does **not** authorize funding obligations or awards.

December 8, 2025

Update on FY25 CoC Program NOFO

HUD has withdrawn the FY25 CoC NOFO to make revisions. A revised NOFO is expected to be released but at this time, HUD has not provided a release date. In addition there is pending litigation of the FY25 NOFO. A federal court decision related to HUD's NOFO process is expected on December 19. **This litigation currently does not affect our local deadlines.**

What This Means for Our Local Competition:

- **Local deadlines remain unchanged.**
- **Applicants should continue working toward their Survey Monkey Apply submission as planned.**

- We do not yet know what changes HUD will make or how they may impact timelines or requirements.

The new tentative deadline to submit a completed e-snaps Project Application to the CoC Lead in Survey Monkey Apply is now **Monday, December 15, 2025, by 4:59 PM (CST)**.

Survey Money Apply programs have been updated and the upload task for the esnaps application is now optional, allowing you to still submit all other materials by the **Wednesday, December 10, 2025, 4:59 PM**.

December 5, 2025

The new tentative deadline to submit a completed e-snaps Project Application to the CoC Lead in SurveyMonkey Apply is now **Friday, December 12, 2025, by 4:59 PM (CST)**.

Survey Money Apply programs have been updated and the upload task for the esnaps application is now optional, allowing you to still submit all other materials by the **Wednesday, December 10, 2025, 4:59 PM (CST)**.

December 4, 2025

The U.S. Department of Housing and Urban Development (HUD) has not yet released the necessary application materials for the CoC Program in e-snaps, nor have they provided the accompanying instructional guides required to complete the application process.

As a result, we are extending the deadline to submit your esnaps Project Application to the CoC Lead in SurveyMonkey Apply. The new tentative deadline to submit a completed e-snaps Project Application is now **Thursday, December 11, 2025, by 4:59 PM (CST)**.

 - **Threshold Review Submission:** Due **within 3 business days** of opening (by December 3 @ 8:59 PM). *Applicants who do not complete this step will not be eligible to move forward in the competition.*
 - **Full Application Deadline:** Wednesday, December 10, 2025 at 4:59 PM CST.

- On **November 13, 2025**, HUD released the **FY2025 Continuum of Care (CoC) Program Notice of Funding Opportunity (NOFO)**. The deadline for the CoC to submit all project applications and Collaborative Applicant materials to HUD is **January 14, 2026**.
- The **Texas Balance of State CoC (TX BoS CoC)** will publish a **Request for Proposals (RFP)** and detailed **Local Application timeline** soon. Please check back regularly for updates.

September 8, 2025

- On September 5, 2025, the Department of Housing and Urban Development (HUD) reissued a Notice of Funding Opportunity (NOFO) for the CoC Builds initiative, permitting the TX BoS CoC to submit a single application.
- Given the expedited one-week deadline of September 12, 2025, and the prior vetting and approval of the Housing Authority of the City of Laredo by the CoC Board, the Board approved resubmission on their behalf without conducting a new local competition.

May 26, 2025

- **The TX BoS CoC is currently accepting proposals for [FY2025 CoC Builds Competition](#)** as of 9:00 AM on May 26, 2025.
- **Intent to Apply is due** via Apply no later than **June 6, 2025, at 4:59:59 PM CDT**.
- **Project Application is due** via *e-snaps* no later than **June 11, 2025, at 4:59:59 PM CDT**
